NOTIFICATION

Whereas, the Government of Andhra Pradesh in G.O.Rt.No.21, Labour
Employment Training and Factories (Labour-II) Department, Dt:08.02.2019,
has declared the Motor Transport Industry in the State of Andhra Pradesh as
a Public Utility Service for the purpose of Industrial Dispute Act, 1947
(Central Act 14 of 1947) for the period from 30.01.2019 to 29.07.2019 for a
period of six months.

2. Whereas, the said period of six months is expired on 29.07.2019.

3. Whereas, the Government of Andhra Pradesh is satisfied that it is
necessary to declare the said industry as Public Utility Service in the public
interest.

4. Therefore, in exercise of the powers conferred by sub clause (vi) of clause
(n) of section 2 of the Industrial Dispute Act, 1947 (Central Act 14 of 1947),
the Government of Andhra Pradesh hereby declare the Motor Transport
Industry in the State of Andhra Pradesh, as a Public Utility Service Unit for a
further period of six months from 30-07-2019 to 29-01- 2020 with
retrospective effect.
