PUBLIC NOTICE

➤ Under section 6BB of Maharashtra Labour Welfare Fund Act, 1953

Under Factory Act, 1948 / Maharashtra Shops and Establishment Act, 1948 / Motor Transport Workers Act, 1961 Small Scale Industries Regulation Certificate / Contract Licenses issued by Central and State Governments, where 5 or more than 5 workers are working, are liable to pay contribution. All shops, Establishments, Institutions and Factories are covered under the said Act. It is mandatory for management of the above said factories, shops, establishments to pay the employer's and employees' contributions before 15th July for the period of June and before 15th January for the period of December.

➤ Under Section on 3 of Maharashtra Labour Welfare Fund Act, 1953

1. All fines realized from the employees.
2. All unpaid accumulations (i.e. Salary, Wages, Bonus, Gratuity) due to the employees but not made to them within the period of 3 years from the date on which they became due should be paid by all employers and managements under Maharashtra Labour Welfare Fund Act, 1953 with all relevant details for quarter ending (March, June, September, December)

We are glad to inform you that Maharashtra Labour Welfare Board is initiating an important step for the "Ease of Doing Business" by introducing "ONLINE PAYMENT PORTAL" for payment of Maharashtra Labour Welfare Fund (MLWF) online without much efforts. The MLWB could be paid online through our portal from 1st January 2020 onwards. We have developed our own portal <https://public.mlwb.in> All establishments can get themselves enrolled on the portal (one time process) and can pay the MLWF online using their credentials which will be generated on the portal during registration and through secured payment gateway using Debit Cards / Net banking / Payment Apps / NEFT / RTGS etc.

The System will Go LIVE From 01.01.2020 onwards

For Online Payment process the steps are as follows

Establishment already Enrolled & Paying MLWF, should provide their Establishment code along with the any payment of MLWF Receipt No. & Receipt date on Board's Portal. Then only they can pay the MLWF as per the process given below.

1. Enroll as Employer	2. PAN no. compulsory	3. Create Employer User ID & Password
4. Login using Employer User ID & Password	5. Enroll your Establishment using establishment PAN/TAN/TIN	6. Generate Establishment User ID & Password
7. Establishment Login using User ID & Password	8. Enter Labour Details like Name, mobile no. etc	9. Generate Challan (ECR) & Pay Welfare Fund Online
