Sub: Provision of knock off auto calculated 14B/7Q challans through miscellaneous challans- regarding.

Sir,

With context to the subject above, it is noted that in the instance of an employer depositing delayed remittances on Unified Portal, the system automatically calculates 14B/7Q with regard to the delayed remittances. The Employer can generate the challan and make online payment against the auto calculated 14B/7Q amount. However, it has been informed by some offices that in some cases, instead of making payment against the auto calculated 14B/7Q, the employer deposits 14B/7Q amount through miscellaneous challans. In such cases, the auto calculated 14B/7Q entries remain in the system as open entries and are shown as pending against Employer and EPFO Field Offices.

2. To overcome this issue, a provision to knock off the auto calculated 14B/7Q with miscellaneous challan has been provided at FOINTEFACE. The process flow of this function is enclosed herewith for reference.

Instruction Manual for
Adjustment of auto calculated 7Q & 14B with
miscellenious challans

PURPOSE OF THE FUNCTIONALITY

Whenever employer deposits late remittances on Unified Portal, system automatically calculates 14B/7Q against delayed remittances. Employer can generate the challan and make online payment against the auto calculated 14B/7Q. It has been informed by some offices that sometimes, instead of making payment against auto calculated 14B/7Q, employer deposited the 14B/7Q through miscellaneous challans. In such scenarios auto calculated 14B/7Q entries remain in the system as open entries and shown on pending to Employer and EPFO field offices. To overcome this issue, a provision to knock off the auto calculated 14B/7Q with miscellaneous challan has been provided at FOINTEFACE.

Under this functionality, Dealing Assistant (Damages) can select the auto calculated 14B/7Q entry and adjust the amount with available miscellaneous challans. This is a two level function. After submission by the Dealing Hand, Task will move to Section Supervisor (Damages) for approval. After approval, auto calculated entry will be removed from the pending list at Employer Portal. Following is the step-by-step process:-

"14B/7Q Knock Off" is two level functionality, DA (Damages) will initiale the case and SS (Damages) will approve the case.




Enter the Establishment ID and click on search button.




All 7Q and 14B auto-calculated challans which are pending at Employer login will be appeared in the below screen.




On click of "Adjust Damages", all the miscellaneous challans paid by the employer at Employer interface will be shown under the grid "Available Miscellaneous Challans of 7Q/14B".




- Select the TRRN available in the grid of "Available Miscellaneous Challan of 7Q/14B".
- Click on "Knock Off Challan" and "OK" button.



- After that the Miscellaneous Challan amount will display against "Knock Off Amount" row in the grid of "7Q/14B Challan Details (Auto-Calculated)".
- If amount of miscellaneous challan is less than the auto-calculated entry, balance amount will be shown against the row "Balance Amount". Until Knock off amount is equal to "Original Amount", Dealing Hand to select another miscellaneous challan for adjustment of auto calculated entry.






