Sub: Gazette Notification No. G.S.R. 132(E) dated 20.02.2020 providing for restoration of normal pension in cases of grant of Commutation- reg.

Madam/Sir,

Please find enclosed a copy of Gazette Notification No. G.S.R. 132(E) dated 20.02.2020 providing for restoration of normal pension after 15 years from the date of commutation.

2. The said notification shall come into force from 20.02.2020.

3. As per the said notification, the following paragraph shall be inserted after paragraph 12 in the Employees' Pension Scheme-

"12B. Restoration to normal pension in cases of grant of commutation- The normal pension in respect of those members who availed the benefit of commutation of pension under the erstwhile paragraph 12A of this Scheme, on or before the 25th day of September, 2008, shall be restored after completion of fifteen years from the date of such commutation."

4.. It has come to notice that some offices have restored normal pension after 15 years from the date of commutation in compliance to court orders/otherwise before the date of notification. Hence, while releasing the arrears an account of restoration of normal pension, it must be ensured that payment of benefits is not made more than once in order to avoid any over payment.

नई दिल्ली, 20 फरवरी, 2020

सा.का.नि.132(अ).—केन्द्रीय सरकार, कर्मचारी भविष्य निधि और प्रकीर्ण उपबंध अधिनियम, 1952 (1952 का 19) की धारा 7 की उप-धारा (1) के साथ पठित धारा 6क द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए कर्मचारी पेंशन योजना, 1995 का और संशोधन करने के लिए निम्नलिखित योजना बनाती है, अर्थात:-

- (1) इस योजना का संक्षिप्त नाम कर्मचारी पेंशन (संशोधन) योजना, 2020 है।
(2) यह योजना राजपत्र में उसके प्रकाशन की तारीख से प्रवृत्त होगी।
- कर्मचारी पेंशन योजना, 1995 में पैरा 12 के पश्चात निम्नलिखित पैरा को अन्तःस्थापित किया जाएगा, अर्थात:-

"12ख. संराशीकरण प्रदान करने के मामलों में सामान्य पेंशन की पुनःबहाली. – इस योजना के तत्कालीन पैरा 12क के अधीन 25 सितम्बर, 2008 को या इससे पहले पेंशन संराशीकरण का लाभ प्राप्त कर चुके सदस्यों के संबंध में सामान्य पेंशन, ऐसे संराशीकरण की तारीख से पंद्रह वर्ष पूर्ण होने के पश्चात पुनःबहाल की जाएगी।"

NOTIFICATION

New Delhi, the 20th February, 2020

G.S.R.132 (E).—In exercise of the powers conferred by section 6A read with sub-section (1) of section 7 of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 (19 of 1952), the Central Government hereby makes the following Scheme further to amend the Employees' Pension Scheme, 1995, namely:—

1. (1) This Scheme may be called the Employees' Pension (Amendment) Scheme, 2020.
(2) It shall come into effect from the date of its publication in the Official Gazette.
2. In the Employees' Pension Scheme, 1995, after paragraph 12, the following paragraph shall be inserted, namely:—

“12B. Restoration to normal pension in cases of grant of commutation. – The normal pension in respect of those members who availed the benefit of commutation of pension under the erstwhile paragraph 12A of this Scheme, on or before the 25th day of September, 2008, shall be restored after completion of fifteen years from the date of such commutation.”
