


MOST IMMEDIATE
OFFICE OF THE COMMISSIONER OF POLICE: DELHI

The execution of the Prohibitory Orders u/s 144 Cr.P.C. in Delhi was not upto the mark today. Following instructions are being issued for strict compliance:

- i) All border pickets be sealed with immediate effect.
- ii) The essential goods/commodities as mentioned in the TP Message No.324/SO-CP dated 23.03.2020 be permitted without any hindrance.
- iii) As regards persons employed in private organisations who are engaged in essential services in the National Capital Territory of Delhi, their respective organisation shall seek Curfew Passes from the office of DCP in which the organisation is located. Addl. DCP-I of the concerned District will issue the passes, after assessing the genuine requirements.
- iv) Those private organisations which are located outside the National Capital Territory of Delhi in the neighbouring districts may similarly seek Curfew Passes for those employees who commute from Delhi to the neighbouring districts from the office of DCP mentioned below.

- v) The government officials who are engaged in essential services will be permitted on the basis of Identity Cards. For employees of private companies to whom the essential service is outsourced by government, the movement shall be permitted on the basis of Identity Card and authorization issued by the concerned government organisation.
- vi) Strict checking shall be done at the border pickets and internal pickets within the city in every Police Station area to ensure that no gathering or movement takes place in contravention of the prohibitory order u/s 144 Cr.P.C.
- vii) Mobile patrolling by four wheelers and motorcycles shall be sent out in the respective areas to ensure compliance of the prohibitory orders issued u/s 144 Cr.P.C.
- viii) Announcements shall be made in the areas for seeking co-operation of the citizens in complying with the prohibitory orders and informing them at the same time that any violation will be dealt with legally.
- ix) SHOs and their supervisory officers shall move around to inspect the arrangements and ensure compliance of this order.
- x) The staff of Traffic Police and PCR will also ensure compliance of the above instructions.
- xi) Local officers shall maintain close liaison with the neighbouring districts of adjoining States.
- xii) Strict legal action be taken against those violating the prohibitory orders u/s 144 Cr.P.C.
