ORDER

In pursuance of the above-mentioned orders read Ref. 10 and the ongoing efforts towards the containment and prevention of spread of novel Coronavirus (COVID-19) in Dadra and Nagar Haveli and the lockdown period of 21 days from 24th March 2020 , 11.59 pm in the country announced by Hon'ble Prime Minister of India, and to deal with the situation for effective implementation of the lockdown measures under the Section 30, sub-section 2 (xviii) , it is hereby ordered that :-

1. All migrants, who are or trying to reach their home states/towns/villages, shall be kept in the shelters /quarantine facilities with proper screening for minimum period of 14 days as per standard health protocol. The Superintendent of Police shall ensure that all such cases are taken directly to nearest quarantine facilities in coordination with the Directorate of Health and Medical Services.
2. All the employers, in the industries or in the shops and commercial establishments shall make the payment of wages of their workers (whether contractual, daily wage or permanent) at their work places, on the due date, without any deduction, for the period their establishments are under closure during the lockdown,
3. Where ever the workers, including the migrants, are living in rented accommodation, the landlords of those properties shall not demand payment of rent for a period of one month
4. If any landlord is forcing labourers and students to vacate their premises, they will be liable for action under the act.
