Subject:- Financial package announced by Government of Haryana in view of Pandemic disease – COVID-19- Subsistence Financial Assistance to the construction workers regarding;

Kindly refer to the subject cited above.


As per the financial package announced by the Government, "the workers who have been registered with the Haryana Building and Other Construction Workers' Welfare Board but have not registered under "Mukhya Mantri Parivaar Samridhi Yojana" (MMPSY) shall be provided subsistence financial assistance in the shape of interim relief @ Rs. 1000/ per week per family during the Lockdown period starting from 30<sup>th</sup> March 2020.

The Haryana Building and Other Construction Workers' Welfare Board have registered 4,56,446 construction workers online, out of which 71043 workers are covered under the MMPSY scheme and in 34,782 cases both husband and wife are registered with the Board and either has been excluded from the list being part of one family. The HBOCWW Board has released Rs. 35,06,21,000/- as first installment of subsistence assistance for disbursement to the remaining 3,50,621 construction workers' families @ of Rs. 1000/- each on 30<sup>th</sup> March, 2020 through NPCI directly in the bank accounts of the beneficiaries. The benefit could not be transferred to 42,150 beneficiaries, due to failure of transactions due to various reasons like Aadhar mapping not done with the Bank account or inactive Aadhar etc. for which corrective measure is to be taken by the beneficiary.

In order to facilitate the workers/general public, the Labour Department has provided the search facility at the labour portal by using URL:- [https://hrvlabour.gov.in/Bocw\\_support](https://hrvlabour.gov.in/Bocw_support), where anybody can check the status regarding the eligibility/payment of financial assistance in respect of 4,56,327 registered construction workers by using Aadhaar number.

The District wise list of beneficiaries of subsistence financial assistance and the failed transaction cases is being attached with this letter for ready reference.


