### ORDER

In pursuance of the latest directions of Ministry of Home Affairs, Government of India and in exercise of powers conferred under Section 30 of the Disaster Management Act, 2005, it is, hereby, ordered that the aforementioned New Guidelines as per Ministry of Home Affairs (MHA) Order No.40-3/2020- DM-I(A) dated 17<sup>th</sup> May, 2020(copy annexed) as well as the National Directives communicated vide Memo No. DMC-SPO-2020/3011 dated 17-05-2010 and No. DMC-SPO-2020/5688 dated 17-05-2020 shall be enforced by all concerned and stakeholders in the manner prescribed below:

1. **LOCKDOWN SHALL CONTINUE TO REMAIN IN FORCE UP TO 31<sup>ST</sup> MAY, 2020.**
2. **THE FOLLOWING ACTIVITIES WILL CONTINUE TO REMAIN PROHIBITED ACROSS THE DISTRICT UP TO 31<sup>ST</sup> MAY 2020 WITH EFFECT FROM 18<sup>TH</sup> MAY, 2020:**
  - i) School, Colleges, Educational/Training/coaching institutions etc. Will remain closed. Online/ distance learning shall continue to be permitted and shall be encouraged.
  - ii) Hotels, restaurants and other hospitality services, except those meant for housing health/Police/ Government officials/ Healthcare workers/ Stranded persons including tourists and for quarantine facilities; and running of canteens at bus depots, railway stations and airports. Restaurants shall be permitted to operate kitchens for home delivery of food items.
  - iii) All cinema halls, shopping malls, gymnasiums, swimming pools, entertainment parks, theatres, bars and auditoriums, assembly halls and however, spectators will not be allowed.
  - iv) All social/ political/sports/entertainment/ academic/ cultural/ religious functions other gatherings and large congregations.
  - v) All religious places/ places of worships shall be closed for public. Religious congregation are strictly prohibited.
3. **THE FOLLOWING ACTIVITIES SHALL BE PERMITTED WITH RESTRICTIONS, EXCEPT IN THE CONTAINMENT ZONES:**
  - i) Inter-State Movement of passenger vehicles and buses, with mutual consent of the State(s) involved.
  - ii) Intra-State movement of passenger vehicles and buses, as decided by the States and UTs.  
Standard Operating Procedures (SOPs) for movement of persons, as mentioned in Annexure-I, shall continue to operate.



#### 4. NATIONAL DIRECTIVES FOR COVID-19 MANAGEMENT.

National Directives of COVID-19 management, as specified in Annexure-II, shall be followed throughout the country.

#### 5. CONTAINMENT, BUFFER, RED, GREEN AND ORANGE ZONES.

- i) The delineation of Red, Green and orange, Zones will be decided by the respective State and UT Governments, after taking into consideration the parameters shared by Ministry of Health & Family Welfare (MoHFW), Government of India (GOI).
- ii) Within the Red and Orange Zones, Containment Zones and Buffer Zones will be demarcated by the District authorities, after taking into consideration the guidelines of MoHFW.
- iii) In the Containment Zones, only essential activities shall be allowed. There shall be strict perimeter control to ensure that there is no movement of people in or out of these zones, except for medical emergencies and for maintain supply of essential goods and services. Guidelines of MoHFW shall be taken into consideration for the above purpose. This shall be enforced by Superintendent of Police, Rewari.
- iv) In the Containment Zones, there shall be intensive contact tracing, house-to-house surveillance, and other clinical interventions, as required. Action, in this regard, shall be taken by Civil Surgeon, Rewari.

#### 6. NIGHT CURFEW:

The movement of individuals shall remain strictly prohibited between 7-00 PM to 7-00 AM, except for essential activities. Local authorities shall issue orders, in the entire area of their jurisdiction, under appropriate provisions of law, such strict compliance.

#### 7. PROTECTIONS OF VULNERABLE PERSONS.

Persons above 65 years of age, persons with co-morbidities, pregnant women, and children below the age of 10 years, shall stay at home, except for essential and health purposes.

8. All other activities will be permitted, except those which are specifically prohibited.

However, in Containment Zones, only essential activities shall be allowed, as mentioned in para 5 (iii) above.

Further, States/UTs, based on their assessment of the situation, may prohibit certain other activities in the various zones, or impose such restrictions as deemed necessary.



## 9. USE OF AAROGYA SETU

- i) *AarogyaSetu* enables early identification of potential risk of infection, and thus acts as a shield for individuals and the community.
- ii) With a view to ensuring safety in offices and works places, employers on best effort basis should ensure that *AarogyaSetus* installed by employees having compatible mobile phones.
- iii) District authorities may advise individuals to install the *AarogyaSetu* application on compatible mobile phones and regularly update their health status on the app. This will facilitate timely provision of medical attention to those individuals who are at risk.

## 10. SPECIAL DIRECTIONS TO ENSURE MOVEMENT OF PERSONS AND GOODS IN CERTAIN CASES.

- i) All States/UT shall allow Inter-State and intra-State movement of medical professionals, nurses and para medical staff, sanitation personnel and ambulances, without any restriction.
- ii) All States/UTs shall allow inter-State movement of all types of goods/cargo, including empty trucks.
- iii) No State/UT shall stop the movement of any type of goods/cargo for cross land-border trade under Treaties with neighbouring countries.

## 11. STRICT ENFORCEMENT OF THE GUIDELINES

- i) State/ UT governments shall not dilute these guidelines issued under the Disaster Management Act, 2005, in any manner.
- ii) All the District Magistrates shall strictly enforce the above measure.
- iii) In order to implement these measures, the District Magistrates will deploy Executive Magistrates as incident Commanders in the respective local jurisdictions, The incident Commander will be responsible for the overall implementation of these measures in their respective jurisdictions.

## 12. PENAL PROVISIONS.

Any persons violating these measures will be liable to proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Sec. 188 of the IPC, and other legal provisions as applicable. Extracts of these penal provisions are at Annexure-III.

The discussions with the stakeholder and representatives of market associations were done and accordingly, the shops/commercial establishments will be allowed to run/operate permissible activities in the Municipal Area as well as Rural Areas as per the schedule prescribed below.



1. No shop/ commercial establishment shall be allowed to be opened unless it is duly numbered and colour coded. Any violation shall attract prosecution under Sections 51 to 60 of Disaster Management Act, 2005 and Section 188 of the Indian Penal Code.
2. All shops, except medical stores and milk/dairy shops, shall remain closed on Sunday.
3. The restrictions of colour coding, numbering and operating hours shall not apply on Hospitals, Clinics, Nursing Homes, Pharmacies, Chemist Shops, Wholesale Sabzi Mandi.
4. All Barbers shops, Salons, Beauty Parlours and Spa shall remain closed.
5. All the shops in the Municipal Area as well as Rural Areas of the District Rewari (except certain shops mentioned hereinafter) to be opened as per the colour coding and numbering (1,2,3,1,2,3.....) already done by EO/ Secretary, MCs & BDPOs in the following manner.

6. Restaurants, Bakeries, Sweets-shops, *Halwais*, *Dhabas* and similar other shops shall maintain proper kitchen-hygiene. In case of any violation, legal action shall be initiated against the owner and manager of such establishment. Rehris selling juices, ready-to-eat eatables, Tea Stalls, Juice Shops etc. shall remain closed.




7. Marriage related gathering may be permitted with the permission of the Incident Commanders -cum- Sub-Divisional Magistrates keeping in mind the social distancing norms.
8. Movement of any individual whatsoever for non-essential purposes shall henceforth remain restricted between 07:00 PM to 07:00 AM within in the district, as well as movement outward the district.
9. Persons above the age of 65, or having co-morbidities, suffering from chronic diseases, pregnant women and children below the age of 10 years shall stay at home except in the case of a medical emergency or essential requirement.
10. Spitting in public place shall be punishable with fine of Rs. 500/- for each offence. All Gazetted Officer in the district shall be empowered to impose such fine. The fine so collected shall be deposited with the concerned local body.
11. Incongested markets with narrow streets viz. Moti Chowk, Gud Bazaar, Jiwally Bazaar and Panjabi Market, four-wheeled passenger vehicles like Car, Jeep etc. shall not be allowed. The Police and Municipal authorities shall erect barriers/barricades to prohibit the movement of four-wheeled passenger vehicles at Bharawas Gate, Kanod Gate and Gokal Gate or any other place as they deem fit.
12. The concerned local authority (MC or BDPO) shall publicise these guidelines amongst the shopkeepers, rehri-walas, fruit and vegetable vendors for generating awareness about maintaining social distancing amongst them. Market associations shall be roped in to motivate and educate the shopkeepers and street vendors to observe these guidelines.
13. Adequate number of teams shall be constituted in all municipal areas and rural areas to enforce the above instructions/directions through extensive checking and challaning. Violation, if any, should immediately be reported to the incident commander -cum-Sub-divisional Magistrate and Station House Officer immediately.
14. This order shall come into force immediately. All the municipalities and rural local bodies shall ensure wide publicity of this order either in their own vehicles, in the vehicles used for door-to-door garbage collection having public address system or by hiring vehicles for this purpose today itself. DPRO shall also give wide publicity through press release and social media.



## OTHER CONDITIONS FOR OPERATING SHOPS:

- i. Social distancing (2 gajkidoori) should be strictly maintained in all such market areas by all concerned i.e. shopkeepers as well visitors/ customers visiting these market areas.
  - ii. Shopkeepers should wear gloves and masks to avoid hand contact. They shall ensure frequent sanitization of all points which come into human contact e.g. door handles etc.
  - iii. Shopkeepers shall ensure the deployment of minimum required staff in their shops to avoid overcrowding. Alternatively they can call the staff in shifts.
  - iv. The guards at the entry point of large size and AC shops should be provided with sanitizers and thermal scanner. Shopkeepers and salesmen shall in variably wear masks while attending the customers. The shop owner shall ensure that no customer is allowed to enter the shop without thermal scanning, sanitization and mask. It shall also be ensure that not more than 5 persons including shopkeepers, helpers and customers are present at a time in any shop.
  - v. The customers/ visitors should wear masks and be asked to stand in queue at a distance of minimum 6 feet. Proper marking of circles at the required distance should be done on regular basis so that customers/ visitors shall wait for their turn.
  - vi. Temporary barriers with thermal scanning system should be provided at the entry and exit points of these market places so as to maintain the flow of customers/ visitors for ensuring social distancing.
  - vii. The customer visiting these market places should not park their vehicles (both two-wheelers and four-wheelers) in front of any shop/ rehris but park these vehicles at designated parking places and walk on foot to the market place. Further while coming out of their vehicles they shall maintain social distancing. It shall also be ensure that the parking areas are managed properly.
  - viii. Citizen should be motivated to visit in minimum numbers (only one member of the family at a time) to these market areas to avoid over-crowding.
  - ix. Municipal staff shall ensure proper cleanliness and sanitization of such market places/areas at regular intervals during day as well as night. Challaning should be strictly enforced against splitting space in open/ market areas.
  - x. Shopkeepers/ Street Vendors shall display a Public Notice regarding downloading "*AarogyaSetu Mobile App*" for public/ customer awareness and motivate them to install the same and regularly update their health status on this app. The shopkeepers shall ensure that all the employees must install AarogyaSetu Mobile App and use the same regularly.
- Food restaurant and food aggregators like Zomato, Swiggy etc. are permitted to operate kitchens for home delivery of food items. They shall ensure that all standards of hygiene like wearing of



masks, gloves, caps etc. are being followed while cooking food in such kitchens. It shall be ensured that kitchen staff or delivery boys are not having any illness or symptoms of cold and cough etc. The thermal scanning of staff on daily basis and regular medical checkup of all such staff be ensured by the owner. Delivery boy shall wear gloves and masks during home delivery. No signature/ thumb-impression of the customer shall be taken by them while delivering the items. Preferably all line electronic mode of payment shall be ensured to avoid contact and maintain social distancing.

- xii. It is needless to mention here that the directions of Ministry of Home Affairs, Government of India regarding lockdown guidelines dated 17<sup>th</sup> May, 2020 should not be diluted in any manner, whatsoever, while complying with the SOP mentioned above.

**ASPER NATIONAL DIRECTIVES FOR COVID-19 MANAGEMENT, THE FOLLOWING SHALL BE COMPLIED WITH AT WORK PLACES AND PUBLIC PLACES:**

- i Wearing of face cover is compulsory in all public and work places.
- ii Spitting in public & work places shall be punishable with fine as may be prescribed in accordance with its laws, rules or regulations by the State/UT local authority.
- iii Social distancing shall be followed by all persons in public places and in public transport.
- iv Marriage related gathering shall ensure social distancing.
- v Funeral/last rites related gathering shall ensure social distancing and the maximum numbers allowed shall not be more than 20.
- vi Consumption of liquor, *paan*, *gutka*, tobacco etc. in public places is not allowed.
- vii Shops will ensure minimum six feet distance (2 gazkidoori) among customers and shall not allow more than 5 persons at the shop

**ADDITIONAL DIRECTIVES FOR WORK PLACE:**

- viii As far as possible, the practice of work from home should be followed.
- ix Staggering of work/business hours shall be followed in offices, work place, shops, markets and industrial & commercial establishments.

Provision for thermal scanning, hand wash and sanitizer will be made at all entry and exit points and common areas.





- xi Frequent sanitization of entire workplace, common facilities and points which come into human contact e.g. door handles etc. shall be ensure including between shifts.
- xii All persons in charge of work places shall ensure social distancing through adequate distance between workers adequate gaps between shifts staggering the lunch breaks of staff etc.

Besides above, taking into considerations the different situations of markets/shops in each sub division in the district, the concerned Sub Divisional Magistrates -cum- Incident Commanders are empowered to issue clarifications directions/ details for closing/ opening of markets/ shops on behalf of the undersigned under Disaster Management Act, 2005 & Epidemic Act, 1897.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general. This order shall come into force with effect from zero hours on 18.05.2020 and shall be effective up to 12:00 midnight on 31.05.2020.

All the Duty Magistrates/ Incident Commanders, SHOs, All Police Officers, All Executive Magistrates will enforce these orders strictly in the areas of their jurisdiction. All Sub-Divisional Magistrates will supervise enforcement of these order in their sub-division. The DETC (Excise and Sales), Rewari, Assistant Labour Commissioner, Rewari, Assistant Director (Industrial Safety & Health), Rewari, Drug Control Officer, Rewari, Food Safety Officer, Rewari and their staff shall carry out regular inspections in the markets to enforce these orders. The Superintendent of Police, Rewari will ensure that the enforcement is strictly carried out at all border check posts and police Nakas. Any violations shall invite criminal proceedings under the relevant provisions of the Disaster Management Act, 2005 (Sections 51 to 60) and the Indian Penal Code, 1860.

The order shall be promulgated by affixing copy thereof at the notice boards of the office of the District Magistrate, Rewari and other government offices, publications in the newspapers having circulation in the area, through the office of the D.I.P.R.O., Rewari, will be hosted on the district website and will be publicised by the DIPRO through other means.
