Resolution:-

In continuation of Ministry of Home Affairs order No. 40-3/2020/DM-I(A), dated 15.04.2020., Government of India, Ministry of Home Affairs has ordered to amend Sub Clause (x) of Clause-1 and Sub Clause (xiii) and (xiv) of Clause(14) vide its order dated 24.04.2020 as under.

Modifications

In Sub clause 1(x), the term "shopping complexes" is replaced with 'market complexes' within the limits of municipal corporations and municipalities.

Inclusions

Sub-clause (xiii) & (xiv) under clause 14 on Commercial and private establishments:

- (xiii) All shops registered under the Shops and Establishment Act of the respective State/UT, including shops in residential complexes and market complexes, except shops in multi brand and single brand malls, **outside the limits of municipal corporations and municipalities**, with 50% strength of workers with wearing of masks and social distancing being mandatory.
- (xiv) All shops, including neighbourhood shops and standalone shops, shops in residential complexes, **within the limits of municipal corporations and municipalities**, registered under the Shops and Establishment Act of the respective State/UT, except shops in market complexes and multi-brand and single brand malls, with 50% strength of workers with wearing of masks and social distancing being mandatory.

2, After careful consideration State Government has decided to make modification and amendment in the above order as under:-

Modifications

In sub clause (x) of Clause 1, the term "shopping complexes" is replaced with 'markets/market complexes'

Inclusions

Sub-clause (xiii) & (xiv) under clause 14 on commercial and private establishments:

- (xiii) All shops registered under the Shops and Establishment Act of the State, including shops in residential complexes **except** shops in markets/market complexes and multi brand and single brand malls, **outside the limits of Municipal Corporations and Municipalities**, with 50% strength of workers with wearing of masks and social distancing being mandatory.

(xiv) All shops, including neighbourhood shops and standalone shops, shops in residential complexes, **within the limits of Municipal Corporations and Municipalities**, registered under the Shops and Establishment Act of the State, **except** shops in markets/market complexes and multi-brand and single brand malls, with 50% strength of workers with wearing of masks and social distancing being mandatory.

3, More over


(1) Sale by e-commerce companies will continue to be permitted for essential goods only.

(2) Sale of liquor, Tobacco, Pan, Gutka Cigarettes etc. continues to be prohibited.

(3) Hair cutting saloons, Barber Shops, Spas, Tea stalls, Restaurants and Hotels shall remain closed.

(4) It is also clarified that the shops will not be permitted to open in areas whether **Rural or Urban**, which are declared as **CONTAINMENT ZONES** in the state.
