ORDER

In view of the direction given by the Government of Odisha in Revenue & Disaster Management Department (DM) vide order No. 2299/R&DM (DM) dated,23-04-2020, Ministry of Home Affairs of Govt.of India vide Notification No. 40-3/2020-DM-II(A) Dated.24th April 2020 & taking into the directives given by the Government from time to time regarding Social Distancing Protocol in order to contain spread of COVID-19 & prevailing heat wave situation, the following direction is given:

- The Pharmaceutical (Medicine) shops shall remain open 24x7.
- All other permitted shops shall remain open from 7 AM to 12 Noon in view
 Social Distancing Protocol due to COVID-19 & prevailing heat wave situation.
- All shops (except the following shops) registered under the Odisha Shops &
 Commercial Establishments Act, 1956 including shops in Residential
 Complexes, Market Complexes except shops in Multi-brand and Single Brand
 Malls, outside the limits of Municipal Corporations and Municipalities with 50%
 strength of workers with wearing of masks and social distancing being
 mandatory.
- All shops (except the following shops) including neighbourhood shops and standalone shops, shops in residential complexes within the limits of Municipal Corporations and Municipalities registered under the Odisha Shops & Commercial Establishments Act, 1956 except shops in market complexes and multi-brand and single brand malls with 50 % strength of workers with wearing of masks and social distancing being mandatory.
- Authorized /Registered shops dealing with Meat/Fish/Chicken /Eggs are to be kept opened.

NOT TO BE OPENED

- Tea Stall/ Food Stall/ Hotel (without permission) / Jewellery / Beauty Parlour
 / Saloon/Gym / Fast Food (Thella)/ Cloth Market / Pan, Tobacco,
 Ghutaka, Chewgum and any food items promoting spitting shall remain closed. (Completely Prohibited)
- The shops operating over the Govt. land by way of encroachment shall not be permitted.

- The shops which are not registered under the Odisha Shops & Commercial Establishments Act, 1956 shall not be permitted to remain open.
- The shops prohibited to operate are not be permitted to open even if the unit/establishments is registered under the Odisha Shops & Commercial Establishments Act, 1956.In view of dilution of Social Distancing Protocol.

ADVISORY

- Senior Citizen and Children are advised not to come outside.
- The registered Shops/Establishments under the Odisha Shops & Commercial
 Establishments Act, 1956 Commercial Establishments and permitted shops are
 encouraged to facilitate the Home Delivery to minimize the movement of
 individual outside the Home.

PENAL PROVISIONS

Any Person/ Entity/Establishments/Shop Keepers violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005 and COVID-19 Regulations 2020, besides legal action under Section 188 of IPC, and other legal provisions as applicable.

This order will be given to immediate effect.
