### CURFEW ORDER UNDER SECTION 144 CrPC. (No.C&S.3/2009/PT.II/153 Dated Shillong, the 25th April, 2020)

Whereas, in view of the prevailing situation concerning COVID - 19 in the state, country and globally:

Whereas, to put in place preventive and mitigation measures to identify and take more stringent steps so the pandemic of COVID - 19 is contained, reduced and eliminated in East Khasi Hills District and Meghalaya, by way of ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department.

Now, therefore, I Smti. M. War Nongbri, IAS, District Magistrate, East Khasi Hills District, Shillong in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby promulgate <u>CURFEW</u> in Shillong Agglomeration and adjoining areas with effect from 06 00 AM of the 26th of April, 2020 (Sunday) up to <u>06:00 AM</u> the 4th of May, 2020 (Monday): -

#### AREAS TO BE UNDER CURFEW:

- 1. Whole of Municipal Area
- 2 Whole of Cantonment Area
- 3. All Census towns areas under Mawlai Block
- 4. All Census towns areas under Mawpat Block
- Areas under Mylliem Block from Umshyrpi Bridge upto 7th Mile, Upper Shillong
- 6. Madanrting, Mawblei, Laitkor, Nongkseh, Umlyngka, Lawsohtun, Mawdiangdiang, Diengiong, Siejiong.

## This Order will Not apply to

- 1. Security Forces
- 2. Medical Teams on duty
- 3. Wholesale and Retail Pharmacies
- 4. Police and Armed Forces
- 5. Fire & Emergency Service
- 6. MeECL & Power Grid
- 7. Food and Civil Supply Department
- 8. FCI
- 9. Public Works Department (PWD)
- 10. Public Health Engineering (PHE) Department
- 11. A.H and Vety Department and Meghalaya Directorate of Dairy Development
- 12. Shillong Municipal Board
- 13. Sanitization Division of Shillong Cantonment Board



- 14. Postal Service, Telecom, Communications & IT Services
- 15 Press, Print & Electronic Media
- 16. Banks, ATM & Treasuries
- 17. Petrol Pumps
- 18 Essential services including Health Services home delivery of LPG Cylinders, home delivery of essential/household items, online food delivery, online services delivery, courier services
- Authorized workshops and designated spare parts dealerships of Health and Family Welfare Department.

- 20. Government Officials on Dury.

These services shall strictly comply with all protocols and procedures including social distancing, disinfection and other advisories of Government in the Health Department, <u>WITHOUT FAIL</u>.

Also, movement of vehicles carrying essential commodities, security forces, medical equipments & goods vehicles are also exempted. However, Drivers and attendants of the vehicles shall be subject to medical screening as per laid down protocols.
