Whereas, Covid-19, is declared as a global pandemic by the World Health Organisation. Government of India also declared it as a disaster and announced several measures to mitigate the epidemic. Government of Kerala, has deployed several stringent measures to control the spread of the epidemic.

And whereas, SRO notification issued by Govt of Kerala as Kerala Epidemics Diseases, Covid 19, Regulations 2020 in official gazette stipulates that all possible measures shall be incorporated to contain the disease.

And whereas, more than 550 live cases are treated in various hospitals in the district as on date, and epidemiological investigation has been carried out in each and every case and their primary and secondary contacts have been traced for effective containment of further transmission of disease. As on 12<sup>th</sup> July 2020, a large number of cases with unknown sources leading to multiple clusters have been identified in the city. The epidemiology of these cases is being established. But their contact tracing is done and identified primary contacts are spread along various LSGs in Thiruvananthapuram district. Most of these unknown cases and local contacts have a large number of contacts throughout the city.

And whereas, the District Authority has examined the matter in detail and is convinced that the need for continuation of total and complete lock down within the limits of Corporation is genuine and urgent to contain the further spread of the Covid-19.


And now therefore, I, Dr. Navjot Khosa IAS, District Collector & Chairperson of District Disaster Management Authority under the powers vested with me as the District Authority to invoke the provisions envisaged in the sec 26, 30 and 34 of the Disaster Management Act 2005 and passes the order as follows.

### **Order**

1. The entire Thiruvananthapuram Corporation will continue to be under strict lockdown with effect from 13.07.2020, 06 : 00 am onwards for a further period of 7 days.
2. Following exemptions are allowed in city limits (other than Ward no 66.Poonthura, Ward no 74, Puthenpally, Ward no 75 Manikyavilakam)
  - a. Offices/Institutions permitted to be open are
    - i. Offices of all Ministers and H'ble Speaker
    - ii. Office of Chief Secretary
    - iii. Offices of Secretaries to govt, of departments of Home, Disaster Management, Health, Local Self Government and NORKA with a maximum of 50% staff.
    - iv. All other department of Secretariat and Directorates of government may function with minimal staff (not exceeding 30%) as deemed necessary by Secretary/HoD
    - v. Government press
3. Following offices of the Government of India, its autonomous/subordinate offices and public corporations shall remain open
  - a. Defence (including production and research), Central Armed Police Forces
  - b. Treasury
  - c. Public utilities (including petroleum, CNG, LPG, PNG, Telecom Post Offices)
  - d. Disaster Management, Early warning Agencies
  - e. Power generation and transmission units,

- f. National Informatics Center
  - g. Airport and Railway Station ( including employees of Airport Authority, Airlines and Indian Railways)
4. Following Offices of State Government, their autonomous bodies, Corporations etc shall remain open.
- a. District Administration, Disaster Management, RDO office, Taluk Office, Village Office
  - b. Police, Home Guards, Civil Defence, Fire and emergency services, prisons
  - c. Treasury
  - d. Health Department, Electricity, Water, Sanitation.
  - e. Local Self Govt Institutions – only staff required for essential services like sanitation, water supply, IQC, CFLTC and other essential duties.
5. Following Additional activities are allowed
- a. Construction activities of basic infrastructure like highways, roads, bridges, and hospital and related infrastructure
  - b. Agriculture/Horticulture/Plantation/Dairy/Poultry /Animal Husbandry/Veterinary
  - c. IT services in Technopark with essential staff
  - d. Taxies and Auto rickshaw maintaining Covid Protocol (Wearing of Mask, Provision of Sanitiser)
  - e. Media offices, data centre operators and telecom operators with minimums staff
  - f. Banking services (except NBFCs) with maximum of 50 % staff. ATMs shall remain open.
6. All other public and private offices may continue to work from home only.
7. Hospitals, medical shops and all related medical establishments including their manufacturing and distribution units, both in public and private sector, such as dispensaries, chemist and medical equipment shops, laboratories, clinics including dental for emergency procedure only, nursing homes, ambulance etc will continue to remain functional. The transportation for all medical personnel, nurses, para medical staff, other hospital support services be permitted.

8. No door delivery of any item except for medicines and food only from Janakiya Hotels run jointly by Kudumbashree and Thiruvananthapuram Corporation is allowed.
9. The public exams in all educational institutions within the city limit of Thiruvananthapuram stand suspended until further orders.
10. Essential grocery shops, bakeries and milk booths shall remain open with following time schedule
  - a. 7.00 am to 12.00 noon - for customers
  - b. 1.00 pm – 3.00 pm - for Stockist, wholesalers
  - c. 4.00 pm – 6.00pm - for customers
11. Transit through National Highways will be permitted with condition that no one will be permitted to stop anywhere while transiting through containment zones
12. No other activity other than the above will be permitted.
13. Night Curfew shall be in force in Thiruvananthapuram district during 9.00 PM to 5.00 AM
14. People are directed to stay at homes/indoor and not to come out. Only essential activities will be allowed in city limits. The movement of persons in or out or within the city limits will not be permitted except for medical emergencies, maintaining supply of essential goods and services.
15. The Incident Commander and Tahsildar, concerned Taluks shall ensure strict containment activities are implemented as per Government instructions.
16. The following areas in Critical Containment Zone will continue to remain under strict and complete lockdown with well-defined perimeter control and single entry and exit points until further orders.

17. Only following activities are permitted in three wards of 66-Poonthura,74- Puthenpally and 75- Manikkyavilakam
    - i. Grocery shops, Milk booths and Bakery shall function from 7.00 am to 2.00pm including restocking
    - ii. All medical and essential services (Public Health Institutions, Water, Electricity) will remain functional 24x7 in wards of critical and buffer containment zone
    - iii. All Banks/NBFC shall remain closed. The Lead bank shall ensure mobile ATMs functional from 10:00 am to 5:00 pm daily.
    - iv. MILMA shall ensure milk and milk products are supplied everyday.
    - v. Regional Manager Supplyco shall provide Mobile Maveli Service to these 3 wards
  18. Night curfew shall remain in force from 7pm to 5 am.
  19. All other directions issued in the order DDMA/01/2020/Covid/CZ -14(5)dated 10.7.2020 shall be strictly adhered to.
  20. Police shall ensure the guidelines issued by Government of India and Government of Kerala regarding the lockdown and containment zones are complied to in letter and spirit.
  21. District Medical Officer shall ensure that Health activities planned as per Dept of Health guidelines are implemented. DMO shall furnish a daily progress report to this office by 8.00PM every day to the email [ddmatvpm.rev@kerala.gov.in](mailto:ddmatvpm.rev@kerala.gov.in).
  22. Any person violating these containment measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of Disaster Management Act 2005, besides legal action under section 188 of IPC
