ORDER

Whereas, a woman resident of Ward No. 13, Mohalla Govindgarh of MC Nahan was tested corona positive on 15th July, 2020 and while tracing the primary and secondary contacts of the said positive case, 10 persons of Mohalla Govindgarh, Nahan have been tested positive of Covid-19.

Whereas, the Mohalla Govindgarh is thickly populated and apprehension of community spread of infection cannot be ruled out. In view of the seriousness of the issue, a meeting was held in the office chamber of the undersigned today itself and in the said meeting, the Superintendent of Police, Sirmaur, Additional Deputy Commissioner, Sirmaur, Additional Superintendent of Police, Sirmaur, Sub-Divisional Magistrate, Nahan and the authorities of Health Department participated and the issue of containing the spread of infection of corona virus was discussed threadbare. It was also agreed upon that in order to avoid community spread and for the sake of testing of primary and secondary contacts, some preventive steps such as closing of shops of Nahan City etc. are required to be taken.

Whereas, the people of Mohalla Govindgarh, Nahan are engaged in various activities in the entire Nahan City and therefore, the imminent threat of infection of virus is there and in order to cope with this situation, immediate preventive measures are required.

And whereas, it is a case of health emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of City Nahan, District Sirmaur is not practicable and possible and therefore, it is necessary and expedient to proceed under Section 144(1)(2) of the Code of Criminal Procedure, 1973.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur, Nahan in exercise of powers conferred under Section 144 (1)(2) of the Cr.P.C., 1973 do hereby order and direct that:-

1. All the shops of Nahan City except chemist shop(s), liquor shop(s) shall remain closed with effect from 18th July, 2020 after 12.00 PM to 21st July, 2020 at 07.00 AM.

2. The movement of local residents of Nahan Town shall not be allowed in Nahan City during the period mentioned above except for medical emergency.

3. All Government Office(s)/Bank(s) shall remain opened and movement of their officer(s)/official(s) shall be permitted for their to and fro journey on production of Identity-Card(s). They shall follow all social distancing norms and the guidelines/orders issued by the Government of India as well as State Government.

4. No officer(s)/official(s) residing in Containment Zone of Mohalla Govindgarh shall be permitted to attend their duty(ies) and they shall keep themselves inside their houses.

5. The Road(s) passing through the city, Nahan shall remain opened for movement of vehicle(s) and only the permission to move the vehicle(s) coming from various part of this District as well as other place(s) shall be permitted and no person travelling in the vehicle(s) shall be allowed to travel inside the city on foot. The National Highway from Delhi Gate to Govindgarh Petrol Pump, Nahan shall remain closed and traffic movement shall be diverted through alternate routes.

6. The Assistant Drug Controller, District Sirmaur at Nahan shall ensure to supply necessary medicine to the people residing in Nahan City through chemist shop keepers.

7. Sanitization in entire Nahan City shall be carried out by the EO, MC, Nahan. He shall ensure that all area(s) including lanes passing through the city are sanitized properly on regular basis.

8. The Chief Medical Officer, District Sirmaur shall ensure to keep the medical team(s) constituted/stationed for the entire city area round the clock to keep strict vigil on the health of the people.

9. The Superintendent of Police, District Sirmaur shall ensure to keep a strict vigil on the enforcement of order in the entire city of Nahan.

10. The DFSC, District Sirmaur shall ensure door to door supply of essential commodities to the needy by keeping liaising with the counselor(s) of MC Nahan and EO, MC, Nahan.


11. The Tehsildar, Nahan, District Sirmaur shall perform as Duty Magistrate for the city area Nahan.

Any person(s) contravening this order shall be liable for prosecution under Sections 269, 270 and 188 of IPC and Section 51 to 60 of the Disaster Management Act, 2005.

This order shall come into force immediately after its issuance.
