ORDER:

In the G.O. 1st read above, Government have extended certain incentives to the Industrial Sector especially MSMEs under ReSTART Policy in the wake of covid-19, so as to enable them to Restart their operations. Accordingly, operational guidelines were issued in the G.O. 2nd read above, for implementation of the ReSTART Policy.

2. In the reference 3rd read above, Director of Industries, Vijayawada stated that as per the representations of Industrial Associations and GM DICs reports, the extension of time is required for filling eligible Industries under ReSTART Policy due to the following reasons:

- i. Claims could not be filed as expected due to lock down restrictions.
- ii. June power bill will be generated in July. Hence, some people are waiting for the power bill of June to be received in July 2020.
- iii. Micro units have been facing problem in filing due to various reasons such as non availability of power bills for Oct 2019 to Jan 2020 as they have not preserved them.
- iv. The Micro units have limited human resources to speed up the process of filing applications.

3. The Director of Industries, Vijayawada has requested the Govt., to issue the following amendments to the GO Rt. No.104, I&C(P&I) Dt.19.05.2020:

1. In Para 2.4 of G.O Rt No 104, Industries and Commerce (P&I) Department Dt 19.05.2020. "All units shall apply for eligibility under ReSTART on or before June 30th, 2020" may be modified as " All units shall apply for eligibility under ReSTART on or before 31 st August 2020".
2. In para 2.6.(2) of G.O Rt No 104, Industries and Commerce (P&I) Department Dt 19.05.2020. "Power Consumption Bills for last 4 months (Oct'19 to Jan'20)"may be modified as "Power Consumption Bills for last 4 months (Oct'19 to Jan'20), however optional for the Micro Enterprises.

3. The committee constituted as per para 2.8 of the G.O.Rt no 104 shall verify the Power Service Connection of the Micro units who have not uploaded the power bills for Oct 2019 to Jan 2020 duly ascertaining the genuinity of such units.

4. After careful examination of the above proposal of Director of Industries, Government hereby issues the following amendments to the G.O. 2nd read above:
