

CURFEW ORDER UNDER SECTION 144 CrPC.

(No.C&S.3/2009/PT.II/255, Dated Shillong, the 9th August, 2020)

Whereas, in view of the prevailing situation concerning COVID - 19 in the state, country and globally;

Whereas, to put in place preventive and mitigation measures to identify and take more stringent steps so the pandemic of COVID - 19 is contained, reduced and eliminated in East Khasi Hills District and Meghalaya, by way of rigorous contact tracing, testing, quarantine, isolation and ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department;

Now, therefore, I Smti. M. War Nongbri, IAS, District Magistrate, East Khasi Hills District, Shillong in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby promulgate **NIGHT CURFEW** in East Khasi Hills District with effect from **10th of August, 2020 (Monday) upto 17th of August, 2020 (Monday) only for timings falling between 09:00 PM to 5:00 AM each day.**

This Order will **Not** apply to:

1. Security Forces.
2. Medical Teams on duty.
3. Wholesale and Retail Pharmacies.
4. Police and Armed Forces.
5. Fire & Emergency Service.
6. MeECL, NEEPCO & Power Grid.
7. Food and Civil Supply Department.
8. FCI.
9. Public Works Department (PWD).
10. Public Health Engineering (PHE) Department.
11. Shillong Municipal Board.
12. Postal Service, Telecom, Communications & IT Services.
13. Press, Print & Electronic Media.
14. Petrol Pumps including Indian Oil Corporation (OIC).
15. Essential services including Health Services, Hospitals, Clinics, Dispensaries, Veterinary clinics, Labs.
16. Online/home food delivery. However, home delivery of food shall be exempted only upto 10:00 PM.
17. Authorized workshops and designated spare parts dealerships of Health and Family Welfare Department, Govt. of Meghalaya.
18. Government Officials on Duty.
19. Officers and Staff of Corona Care Centres.
20. Information & Public Relations Department.
21. National Highways & Infrastructure Development Corporation Ltd (NHIDCL).

These services shall strictly comply with all protocols and procedures including social distancing, limiting of field staff to the barest minimum and other advisories of Government in the Health and Family Welfare Department,

WITHOUT FAIL.

Also, movement of vehicles carrying essential goods, security forces, medical equipments and shops for repair of trucks on highways are exempted. However, Drivers and attendants of the vehicles shall be subject to medical screening as per laid down protocols.




However, exemption granted to Official and Non-Official emergency/essential services, establishments and agencies above shall not extend to Containment Areas as listed in Annexure-I attached to this Order, except for exemption granted therein.

Curfew passes for timings falling between 09:00 PM to 05:00 AM with effect from 10th of August, 2020 (Monday) upto 17th of August, 2020 (Monday) to be obtained via online application @ eastkhasihills.gov.in.

In view of the urgency of the matter this Order has been made ex parte.
