ORDER

Whereas, the State Disaster Management Authority, Mizoram, had reopened economic activities and inter-state movement of persons vide Order dated 31.07.2020 in pursuance of the directions of the National Executive Committee conveyed vide Ministry of Home Affairs, Govt. of India Order No.40-3/2020-DM-I(A) dt. 29.07.2020;

And whereas, with the reopening of economic activities and inter-state movement has resulted in a surge in movement of people;

And whereas, a significant number of positive cases has been detected among primary and secondary contacts and the risk of community spread is extremely high at this juncture;

And whereas, it is considered necessary to undertake swift and extensive tracing and testing of contacts of COVID-positive persons and carry out random testing among high risk groups within Aizawl municipal area;

And whereas, in order to facilitate collection and testing of swab samples of primary and secondary contacts at different localities in Aizawl, and to contain further contagion, it is considered necessary to curtail economic activities and movement of persons within Aizawl Municipal area for a brief period to slow down the spread of the virus;

And whereas, the healthcare system of the State is currently overwhelmed by the increasing number of COVID-positive patients detected recently, including a significant number of paramilitary personnel;


Now therefore, the undersigned, in his capacity as Chairman, State Executive Committee of the Mizoram State Disaster Management Authority and in exercise of the powers conferred by Section 22(2)(h) & 24(l) of the Disaster Management Act, 2005 hereby orders a lockdown to be implemented within Aizawl Municipal area as per the guidelines appended herewith from 8:00 P.M of 16.08.2020 till 04:30 A.M of 21.08.2020.

Lengpui Airport is excluded from the lockdown and the extant guidelines dated 31.07.2020 shall be applicable to the rest of the State insofar as economic activities are concerned.

1. Lengpui airport chu hawn chhunzawm a ni ang. Amaherawhchu, Lengpui airport atanga Mizoram rawn lut tur te chuan *mCOVID-19 mobile application* a *mFlight* emaw *mcovid19.mizoram.gov.in* a *mpass-FLIGHT* hmangin phalna an la hmasa tur a ni.
2. Pawn lam atanga Aizawl municipal area a luh leh Aizawl municipal area atanga chhuah (zin veivah) khap a ni. Hei hian Home department-in Mizoram luh phalna a pek te, Mizoram pawna chhuak tur te, damlohna (medical emergency) leh chhiat tawh thil-a chungkhat hnai zual (pi leh pu, nu leh pa, tu leh fa leh pianpui unau) te veivahna a huam lovang. Medical emergency leh chhiat tawh thilah te chuan Deputy Commissioner, Aizawl phalna lak tur a ni a, phalna dil dan tur kalphung (online/offline) erawh chu Deputy Commissioner, Aizawl in mipui hriat atan a puangzar ang.
3. Aizawl municipal area pawn atangin nitin mamawh (essential commodities) chauh lak luh phal a ni. Heng bungraw chawkluh leh Aizawl atang/paltlanga heng bungrua te thiar chungchangah Deputy Commissioner in ruahmanna a siam ang.
4. Aizawl municipal area-ah chuan nitin mamawh (essential commodities) zawrhna dawr te chu Deputy Commissioner leh LLTF te ruahmanna siam angin hawn theih a ni ang. Dawrkai te hian hand sanitizer, anmahni dawrtute hman tur dahin social distancing an zawm tha tur a ni. Tin, anmahni dawrtute hming, veng, phone number leh an rawn dawr hun ziah luhna register siamin dawr neitu ten an ziak lut vek tur a ni.
5. Essential commodities dawr hawn phalsak te hi (damdawi dawr tiam lovin) tlai dar 5:00-ah khar vek tur a ni.
6. Zirna in, training institute leh sakhaw biakna hmunte chu khar chhunzawm zel a ni ang. Aizawl municipal area chungga undergraduate leh postgraduate examination (off-line) te pawh thulh rih a ni anga, online examination erawh chu kalpui a ni ang.
7. Mitthi vuina-ah mi 50 aia tam punkhawm khap a ni. Mitthi vui chungchangah chhiatni/thatni chungchanga Order ni 13.08.2020 a chhuah khauh taka kenkawh tur a ni ang.
8. Aizawl municipal area huamchhunga chengte phalna nei lovin tumahin mahni in leh compound an chhuahsan tur a ni lo. Hei hian a hnuaia mite leh an veivahna motor a huam lovang:

- a) Heng Department hnuaia Sawrkar hnathawkte office kal leh haw -

- c) Medical leh veterinary emergency duty leh hospital-a thawkte.
- d) Mizoram Kohhran Hruaitu Committee member-te.
- e) Bank, ATM, postal, telecom service provider leh Food Corporation of India-a hnathawkte.
- f) Print & electronic media, cable leh internet services a thawkte.
- g) Bawnghnute sem leh bawlhhlawh paih hna thawktute.
- h) Petrol pump leh LPG delivery a thawktute.
- i) Courier, home delivery leh e-commerce service-te.
- j) Private security service-te.
- k) Airport atanga thlawhna a lo haw quarantine tur buaipuitute.
- l) Mizoram University hnuaia post-graduate **online** exam buaipuitu faculty member-te.

Heng zawng zawng te hian anmahni nihna ti chiang tu photo identity card an keng ngei ngei tur a ni.

9. Pawn (dawr/office/damdawin/vantlang hmun) chhuak tur reng reng chuan (face mask emaw hmanraw dang hmangin) hmai an tuam ngei tur a ni.
