**ORDER**

WHEREAS, vide previous orders certain directions were issued for phased re-opening of Places of Worship, Hotels, Restaurants, & other Hospitality Services and Shopping Malls w.e.f. 08.06.2020, further, in view of Government guidelines orders dated 30.06.2020 and 13.07.2020 were also issued.

WHEREAS, the Ministry of Home Affairs (MHA), Government of India (GoI) vide order No. 40-3/2020-DM-I(A) dated 29.07.2020 and Department of Home, Government of Punjab (DoH, GoP) vide letter No. 560 dated 31.07.2020 had issued the guidelines and accordingly this office had, further, issued the orders vide No. DCM/MA/2020/17606 dated 31.07.2020.

WHEREAS, now Department of Home, Government of Punjab (DoH, GoP) vide letter No. 592 dated 17.08.2020 has issued orders vide which restrictions have been imposed on certain activities in all the cities of the State.

THEREFORE, I, Girish Dayalan, IAS, District Magistrate, in continuation of order dated 31.7.2020, in exercise of powers conferred under Section 144 of Cr.PC hereby issued the additional restrictions within municipal limits of all the cities of the District w.e.f. 18<sup>th</sup> August, 2020 till further orders as under:

**1. Night curfew (9:00 pm to 5:00 am)**

Movement of individuals for all the non-essential activities shall remain prohibited between 9.00 pm to 5.00 am within municipal limits of all the cities of the District.

However, essential activities including operation of multiple shifts, movement of persons and goods on National and State Highways and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and aeroplanes will be permitted.

Similarly, all industries running into 2-3 shifts will also remain open.

2. **Restrictions on timings:**

- Restaurants, Hotels and other Hospitality Units: **till 8:30 pm.**
- Shops and shopping Malls : **till 8:00 pm**
- Restaurants/Hotels situated within shopping malls: **till 8:30 pm**
- Liquor vends: **till 8:30 pm**

3. **Penal provisions:** Any violation of these guidelines and lockdown measures shall be punishable under sections 51 to 60 of the Disaster Management Act, 2005 besides legal action under section 188 of Indian Penal Code(IPC).

4. **Advisories:** The Health & Family Welfare Department, Punjab has issued advisories on different subjects. All concerned shall ensure compliance of these advisories.

5. **Any violations shall invite criminal proceedings under the relevant provisions of the Disaster Management Act, 2005 and the Indian Penal Code, 1860.**
