DRAFT NOTIFICATION

No. ESIS 2015/C.R. 150/RAKAVI-2.— In exercise of the powers conferred by sub-section (5) of section 1 of the Employees' State Insurance Act, 1948 (34 of 1948), in its application to the State of Maharashtra and in partial supersession of all earlier notifications issued in this behalf with respect to the number of persons employed in the establishments, the Government of Maharashtra, in consultation with Employees' State Insurance Corporation and with the approval of the Central Government, after having given one month notice as required by said sub-section (5) of section 1, hereby appoints the date 1st October 2020, to be the date on which all the provisions of the said Act shall extend to the classes of establishments mentioned in column (2) of the Schedule appended hereto wherein ten or more persons are employed, or were employed on any day of the preceding twelve months situated in the areas in which the provisions of said Act have been brought into force under sub-section (3) of section 1 of the said Act.
