Whereas it has been made to appear to me that the district is on the verge of a super spread in Covid 19 positive cases in spite of the collective efforts of all departments and any laxity in following Covid Protocol will seriously endanger human lives in large numbers and affect public health and

Whereas it has also been made appear to me that in case of a super spread, the health system and other facilities in the District may be overwhelmed leading to high mortality if all possible steps to check the surge and Covid 19 protocols are not strictly followed in the District. In many Panchayaths and Municipalities, the Covid positive cases are reported on a daily basis in large numbers.

Whereas it has been made to appear to me that in the wake of the surge in number of Covi-19 cases in the State, public congregation and gathering pose an impeding danger for a super spread of the infection and unwanted congregation of people needs to be discouraged.

I, Shanavas.S, District Magistrate and Chairperson, District Disaster Management Authority, Thrissur District, do hereby ex parte order that any voluntary congregation of more than 5 persons in public places is prohibited in the entire district and every person in the entire district to strictly follow Covid protocol at all time while interacting with other persons including social distancing, use of masks and sanitising. The restrictions shall be in force in the district with effect for from 0900 hours on 3rd October 2020 to 2400 hours on 31st October 2020 or otherwise modified hereafter, provided that;

- 1) Gathering of maximum of 50 persons for marriages and 20 persons for funerals are only allowed.
- 2) Gathering of maximum 20 persons are only allowed for Government functions/religious functions/prayers/political and other social/cultural activities.
- 3) Gathering at market places/bus stand/public transportation/office/shops/work places/hospitals/examinations/recruitments/industries are allowed to function only by strictly adhering to social distancing, other Covid protocol and Break the Chain Protocols.

The District Police Chief, Thrissur City and Rural shall implement the order as above. The Secretaries of all Local Self Governments shall make arrangements to disinfect all the public/market places very urgently.

This order will not be applicable to Law Enforcement Agencies and other essential services.
