



No.21/07/2015-5L/ 1530 To enable the employees working in the Shops and Commercial Establishments situated in the State of Punjab who are voters of Haryana to cast their votes in Haryana, it is considered in public interest to declare 3rd November, 2020 as a paid holiday within the revenue jurisdiction of the districts adjoining the areas of Haryana State.

Therefore, in exercise of the powers conferred by second proviso to sub-section (1) of Section 10 of the Punjab Shops and Commercial Establishments Act, 1958(Punjab Act No. 15 of 1958) and all other powers enabling him in this behalf, the Governor of Punjab is pleased to fix Tuesday, falling on 3rd November, 2020 to be a 'closed day' for the employees who are voters of Haryana working in Shops and Commercial Establishments in the districts adjoining to the State of Punjab. However, 3rd November, 2020 (Monday) shall not be a 'closed day' in lieu of weekly off falling between 1st November, 2020 and 7th November, 2020 on account of Bye-election to 33-Baroda Assembly Constituency, 2020 in the state of Haryana.




