## LABOUR FACTORIES BOILERS AND INSURANCE MEDICAL SERVICES DEPARTMENT (LAB-II)

EASE OF DOING BUSINESS (EoDB) - CONTRIBUTIONS OF EMPLOYER AND EMPLOYEE TOWARDS WELFARE FUND - INTRODUCING ONLINE PAYMENT FACILITY FOR THE CONTRIBUTIONS UNDER ANDHRA PRADESH LABOUR WELFARE FUND ACT, 1987 - MANDATING ONLINE PAYMENT.

### **NOTIFICATION**

Whereas, in the Andhra Pradesh Labour Welfare Fund Act, 1987 section (10) sub-clause (1) and vide Gazette Amendment No.7, Dt: 09.04.2015, it is directed that 'Every employee shall contribute thirty (30) rupees per year to the Fund and every employer shall, in respect of each such employee, contribute seventy (70) rupees per year to the Fund'.

Whereas, the Government of India, Department of Industrial Policy and Promotion, Ministry of Commerce and Industry, New Delhi have made certain recommendations and out of the said recommendations, one of the recommendation is "for collection of contributions under Andhra Pradesh Labour Welfare Fund Act, 1987 should be made through an online system".

Accordingly, the State Government is introducing an online facility for payment of contributions under Andhra Pradesh Labour Welfare Fund Act, 1987 by employer and employee. It is hereby mandated that, all contributions from employee and employer under the Andhra Pradesh Labour Welfare Fund Act, 1987 shall be remitted through online mode only. Process for making online payment under Andhra Pradesh Labour Welfare Fund Act, 1987 in the prescribed format is annexed.

- 2. The user shall select the option 'ONLINE PAYMENT OF WELFARE CONTRIBUTION' and registers with portal by providing information such as
  - a. Name of the person
  - b. Phone No.
  - c. Name of establishment
  - d. Labour Identification Number /Labour Welfare Account (if already registered)
- 3. After registering, the applicant shall enter the following details for making payment

  - a. Yearb. Month ( Can select multiple months)
  - c. Number of Workers to pay contribution
  - d. Total Contribution (Auto calculated) Rs 100 \* (3)
- 4. The applicant can select the payment mode (net banking and Debit/Credit Card )
- 5. After successful online payment, the applicant will receive a receipt which can be printed
