In exercise of the powers conferred by of section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act 30 of 1979), the Government of Kerala hereby make the following rules further to amend the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983, the same having been previously published as per notification No.E2/166/2020-LBRD dated 15th September, 2020 in the Kerala Gazette Extraordinary No. 2103 dated 16th September, 2020 as required by sub-section (1) of the said section, namely:-



RULES

1. *Short title and commencement* .- (1) These rules may be called the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Amendment Rules, 2020.

(2) They shall come into force at once.

2. *Amendment of the Rules* .- In the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983,-

(1) In rule 2, after clause (d), the following clause shall be inserted, namely:-

“(da)"Labour Commissionerate Automation System" means a software owned and operated by the Labour department to cater end to end solutions to the employers, employees and labour administrators." ;

(2) In rule 3,-

(a) in sub-rule (1) for the words “in triplicate” the words “through Labour Commissionerate Automation System” shall be substituted ;

(b) for sub -rule (2), the following sub-rule shall be substituted ;

"(2) Every payment of fees for the application for the registration of establishment shall be remitted through Labour Commissionerate Automation System.” ;

(c) sub-rules (3) and (4) shall be omitted;

(3) In rule 7,-

(a) in sub-rule (1) for the words “ in triplicate” the words “through Labour Commissionerate Automation System” shall be substituted ;

(b) clause (ii) to sub-rule (3) shall be omitted.

(c) sub-rule (4) shall be omitted.

(d) sub-rule (5) shall be renumbered as sub-rule (4) and for sub-rule (4) as so renumbered the following sub-rule shall be substituted, namely:-

" (4) Every payment of fees for the application referred to in sub -rule (1) shall be remitted through Labour Commissionerate Automation System as required by rule 20;”

(4) In rule 14, for sub-rule (2), the following sub-rule shall be substituted, namely:-

“(2) The application shall be in Form IX and shall be made through Labour Commissionerate Automation System not less than thirty days before the date on which the licence expires, and if the application is so made the licence shall be renewed automatically.” ;

(5) In rule 20, for the words " by chalan in any Treasury in the State under the head of account specified by the Government" the words “through Labour Commissionerate Automation System" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As part of Ease of Doing Business, Government of Kerala have decided to make suitable amendments to the Kerala Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983 so as to simplify the procedure for registration and renewal of licence.

The notification is intended to achieve the above object.
