7. State Reforms Action Plan-2020 mandated by DPIIT, Govt of India under Ease of Doing Business.

ORDER:

In the reference 1st read above, Government of Andhra Pradesh have enacted a law for Single Window Clearances in the year 2002 to provide all clearances required for starting and operating an industry, within a specified time period.

2. Government of Andhra Pradesh is committed to improving the Ease of Doing Business in the State. In order to increase ease of Government procedures, ensure transparency and enable a conducive business environment, the Government continuously strives to strengthen the systems.

3. Consequently, in the reference 2nd read above, Government have issued modified Single Desk Policy 2015 to create a one stop shop to provide all necessary clearances/ renewals for starting and operating an industry, within 21 working days. The policy eliminates the need to interact with multiple regulatory authorities for obtaining clearances for setting up industry in the State. Additionally, the Single Desk Portal eliminates the need for physical document submission by providing for online filing, document submission and tracking of applications. It also allows payments to be made electronically to obtain timely approvals online.

4. To ensure seamless, integrated and consistent delivery of all services, in the reference 5 read above, it was mandated that all services covered as a part of Single Desk Policy 2015 will be delivered online and through Single Desk Portal only and the competent authorities should not entertain the applications directly from the entrepreneurs.

5. With an aim to be the one-stop-shop for delivery of all industry related services, as per recommendations of Business Reform Action Plan 2019 for Ease of Doing Business, in the reference 6 read above, 15 new services are added to the service portfolio of the Single Window.

6. To further strengthen the service portfolio of the Single Window Portal of Andhra Pradesh, 17 additional services as listed in Annexure shall now be provided through the Single Window Portal (<https://www.apindustries.gov.in/APIIndus/>) and the departments concerned for the delivery of the services are hereby directed that:

- All industrial applicants shall be directed to apply for the services (in Annexure) through Single Window Portal only. Departments are requested to take necessary steps to facilitate seamless redirection to Single Window Portal. No physical / manual application shall be accepted in addition to the online application.
- No physical copies of documents shall be requested by the Competent Authority and documents uploaded with online application should be sufficient.
- There should be no requirement of any physical touchpoint between the applicant and the Department/Agency. The applicant should not be required to get in touch with department authorities physically except in cases where inspection/ site visit is mandated by law
- Downloaded certificate shall be considered as valid and should not request physically signed/ stamped certificate.

7. The Director of Industries, Andhra Pradesh shall take necessary action in the matter accordingly.
