No: GHR/2021/12/IBA/112020/502190/M(3):- **WHEREAS** certain draft rules were published as required by sub-section (1) of section 31 of the Boilers Act, 1923 (5 of 1923), at page 243-1, in the Gujarat Government Gazette, Extra Ordinary, Part IV-A, dated the 18<sup>th</sup> December, 2020, under the Government Notification, Labour and Employment Department No. GHR/2020/158/IBA/112020/502190/M3 , dated the 9<sup>th</sup> December, 2020 inviting objections and suggestion from all persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the *Official Gazette*;

**AND WHEREAS** no objection or suggestion has been received by the Government in respect of the said draft notification;

**NOW, THEREFORE**, in exercises of the powers conferred by section 29 of the Boilers Act, 1923 (5 of 1923), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Boiler Rules, 1966, namely:-

1. These rules may be called the Gujarat Boiler (Amendment) Rules, 2021.
2. In the Gujarat Boiler Rules, 1966 (hereinafter referred to as the "said rules") in rule 13 for the word "areas", the word "region" shall be substituted.
3. In the said rules, rule 38 and rule 45 shall be deleted.
