ORDER

SUB: MEASURES FOR CONTAINMENT OF COVID-19

In partial modification of Order No. 01/Home/2021 dated 29/01/2021 read with Order No. 03/Home/2021 dated 27/2/2021, the undersigned, in exercise of powers conferred under section 22(2) (h) of the Disaster Management Act, 2005, in his capacity as Chairperson, State Executive Committee, hereby issues following guidelines, in addition to those already issued vide Order No. 01/Home/2021 dated 29/01/2021 and No. 05/Home/2021 dated 11/03/2021 for strict implementation and compliance within the State of Sikkim, with immediate effect:-

1. Restriction on movement of vehicles at night.

- (i) There shall be no movement of vehicles after 10.30 pm till 6.00 am except for emergency purposes. The District police shall ensure strict compliance.
- (ii) This restriction shall not apply to commercial goods vehicles including LCVs and vehicles on emergency duty.

2. Market, Shops, Institutions, Commercial and Industrial establishments.

- (i) All Commercial establishments including Restaurants, Bars, Night Clubs, Discos, Pubs, Gyms etc shall close by 10.00 pm every day. However, this shall not apply to the in-house guests staying in the hotels.
- (ii) All commercial establishments shall strictly follow COVID-19 protocol viz. Social distancing norms, wearing of masks, sanitizations, installation of Aarogya Setu App etc.

3. Special drive for maintenance of social distance, wearing of masks and hand sanitization.

- (i) All schools, institutions and establishments shall carry out special drive to ensure that students, employees and customers continue to follow the norms of the social distancing and wearing of masks at all times.
- (ii) The police shall also increase vigil in this regard, create awareness and strictly enforce the norms in public places.
