ORDER

Whereas, it has been brought in the knowledge of undersigned by Executive Magistrate cum Naib Tehsildar Holi that Two persons in Vill Kuther PO Holi Tehsil Bharmour District Chamba HP have been tested positive for COVID-19. It has been further intimated that there is a need to geographically quarantine this area so that the spread of COVID-19 is contained.

Whereas, it is a case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area as mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed ex-parte under section 144 Cr.PC of the Code of Criminal Procedure, 1973.

Therefore, in view of the above circumstances and to take immediate emergency containment measures, I, Manish Kumar Soni, HPAS, Sub Divisional Magistrate Bharmour, Distt. Chamba, Himachal Pradesh, in exercise of the powers vested in me under section 144 of the Code of Criminal Procedure, 1973 and subsequent powers delegated to the undersigned by the District Magistrate Chamba, Distt. Chamba, H.P. vide his office's order no. CBA-DA-2(31)/2020:18365-79 dated 14-07-2020, do hereby order and direct the **Complete sealing of the area of the Micro containment zone** as shown below;

It is further ordered that:


1. Naib Tehsildar Holi shall be Magistrate on duty to implement all the containment efforts in the zone mentioned above.
2. Clear entry and exit points shall be established for stringent perimeter control of the Containment Zone by the Naib Tehsildar Holi, SHO Bharmour and Block Development Officer, Development Block Bharmour.
3. Under no circumstances shall there be any ingress/ougress of any person residing in the area of the Micro Containment Zone at any time except for persons involved in the enforcement of containment plan and maintaining essential services including medical emergencies.
4. Details of all persons (name, address and mobile number) moving out of the perimeter of the Micro Containment Zone for essential/emergency services will be recorded by the SHO Bharmour, as the case may be, and they will be followed up through IDSP (Integrated Disease Surveillance Programme) by CMO Chamba.
5. Every person residing within or entering the Containment Zone shall wear a face cover/mask.
6. No person shall leave his/her home on foot or through vehicle or travel or move around, roam around or stand or be found on any public path or place in the aforementioned Micro Containment Zone, except for medical emergencies with the specific permission of the undersigned. There shall be no curfew relaxation hours in respect of the Containment Zone.
7. Supplies of essential items in the Containment Zone shall be done through home delivery by the Block Development Officer, Development Block Bharmour and SHO Bharmour through Pradhan/ Secretary of concerned Gram Panchayat.

8. All residents of Containment Zone shall download, install and use Aarogya Setu App. Pradhan and Panchayat Secretary of concerned Gram Panchayat shall ensure 100% coverage of Aarogya Setu App.
9. BMO Bharmour shall ensure implementation of all protocols prescribed by the Health Department in respect of the Containment Zone and the Buffer Zone.
10. BMO Bharmour shall obtain a list of fresh arrivals from outside the District in the Containment and Buffer Zone from BDO Bharmour and they shall be particularly and actively followed up by the Health Department.

This order shall come into effect immediately and shall remain in force till further orders.


Any person contravening this order shall be liable for prosecution under Section 269, 270 and 188 of Indian Penal Code, 1860.
