ORDER UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE

WHEREAS, a fresh surge of COVID-19 cases are increasing in the District of Dadra & Nagar Haveli which has risen concerned to the District Administration;

AND WHEREAS, it is imperative to take necessary precautionary steps towards the containment of the said virus;

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, IAS, District Magistrate, Dadra & Nagar Haveli hereby Order that:

1. Any congregation of more than 05 people at Public Places with the exemption of activities allowed in the order quoted in the preamble above through the District is prohibited.
2. Any person found not wearing a mask and violating social distancing norms at all Public/Work Places shall be fined as per order quoted in the preamble above.
3. No shops/ Commercial activities shall be carried out in 100 Mtrs. peripheries around Shri Vinoba Bhave Civil Hospital, Silvassa except essential food and medical shops.
4. Curfew timings shall remain from 06:00 p.m. to 06:00 a.m., however the operation of medical services, delivery of food items, Industrial workers commuting for shift duties are exempted.
5. Complete Curfew is hereby imposed on all weekends (Saturday & Sunday and all Public Holidays).

This order shall come into force immediately from the date of issue and shall remain in force till 31st May, 2021.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
