CRIL MISC CASE NO. 3 of 2021

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE

Imphal, the 8th May, 2021

Whereas, the Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) read with Section 22 of the Disaster Management Act, 2005 has issued order No.H-1601/6/2020-HD dated the 7th May, 2021 for imposition of **CURFEW** in view of the increasing trends in the spread of COVID-19 infections;

Whereas, it is also stated in the aforesaid order that curfew shall be imposed from 8th May to 17th May, 2021 and the District Magistrates have been directed to issue orders accordingly;

Whereas, adoption of immediate preventive and precautionary measures to strictly enforce the provisions of 'the Manipur Epidemic Diseases (Enforcement of COVID-19 Guidelines) Regulation, 2020' is required in the area which is described in the schedule given below;

Whereas, there is emergency and circumstances do not permit the serving of notice in due time upon the public, this order is passed ex-parte under Section 2 of Section 144 of Cr.P.C.1973 and is directed to the public in general;

Now, therefore, I, Th. Kirankumar, District Magistrate, Imphal West District, Manipur in exercise of the powers conferred under Sub-Section 2 of Section 144 of Cr.P.C., 1973 do hereby prohibit the movement of any person outside their respective residences from 8th May to 17th May, 2021;

Further, this order shall not apply to the agencies of the Government Department(s) involved in enforcement of law and order and the curfew imposed shall not be applicable to the activities listed below and shall be allowed free movement:

- i) All health care facilities including animal healthcare, hospitals, clinics, nursing homes and movement of health care workers.
- ii) all pharmacies, including those selling veterinary medicines.
- iii) all persons going for COVID-19 vaccination, COVID-testing and medical emergencies.
- iv) All employees and personal staff working in Media, Power, Fire Service, PHED, CAF & PD, Home, Health, Relief & DM, Police Department and District Administration.
- v) Only goods vehicles, oxygen supply related vehicles, LPG and oil tankers and vehicles of other essential services like power supply, fire service, water supply, waste/garbage clearance, public distribution system, medical/covid services, electronic and print media, internet and telecom service providers and vehicles of departments/organisations permitted to be functional;
- vi) Opening of petrol pumps and LPG outlets and movement of staff of IOCL;
- vii) Movement of staff of Imphal airport and passengers.
- viii) Hotels for lodging with minimum staff.


In case of emergencies and for persons who want to take out procession for marriage, funeral, etc. within the scheduled area, applications may be made to the undersigned or to the Superintendent of Police, Imphal West District for permission and they shall not take out procession until a written permission is obtained from authorities.

Copies of this order are pasted on the notice boards of the undersigned and copies may also be sent to the DIPR, AIR and DDK, Imphal for wide publicity.
