**Order under Section 144 of Cr. P.C. read with relevant provisions of Epidemic
Disease Act, 1897 and HP Epidemic Disease (COVID-19) (Amendment) Regulations
2020 and the Disaster Management Act 2005**

WHEREAS, with an aim to control the spread of the COVID-19 pandemic, State wide Corona Curfew was imposed w.e.f 06:00 AM of 7th May to 06:00 AM of 17th May 2021 vide Order No. Rev(DMC)(C)20-2/2021-COVID 19-III Dated 05th May 2021 by the Chairman, State Executive Committee (SEC) H.P;

WHEREAS, the Chairman, State Executive Committee taking into consideration the increase in incidence of COVID-19 cases and fatalities across the State, has directed imposition of additional restrictions during the Corona Curfew vide Order No. Rev(DMC)(C)20-2/2021-COVID 19-III Dated 08th May 2021 **(Copy enclosed)**;

NOW THEREFORE, I, D C Rana, IAS, District Magistrate, Chamba District Chamba in exercise of the powers conferred in me under section 144 of Cr. PC, and in the continuation of this office order No. CBA-Relief-3(36)/2020-1990/2098 dated 05th May, 2021 vide which CORONA CURFEW was imposed in the District, and in compliance of the aforementioned directions of SEC, do hereby order that:

1. The commercial and private establishments as allowed to open by the aforementioned orders shall function from 10.00 AM to 1.00 PM in the District from Monday to Friday. The markets on weekends will function as per this office order dated 28th April, subject to timings of 10:00 AM to 1:00 PM.

2. The operation of public stage and contract carriages shall remain suspended in the District during the period of Corona Curfew. RTO Chamba and RM-HRTC shall ensure compliance of the same.
3. Private vehicles shall be allowed to ply only for:
 - a. For medical emergencies and purchase of medicines on production of valid doctors' prescription.
 - b. For purpose of testing, treatment and vaccination for COVID-19.
 - c. Armed forces and paramilitary personnel for joining duty or going on leave, on production of leave certificate.
 - d. For medical officers, government officers for official duty on production of Government Identity Card.
 - e. For essential shops owners their employees/service providers on production of valid ID card and shop license.
 - f. Labours working on projects/construction sites may move with the ID to be issued by the officer of the department concerned.
4. The directions issued by this office via orders under section 34 of the Disaster Management Act, 2005 dated 13th April 2021, 26th April 2021, 28th April 2021 and 01st May 2021 shall remain in force unless superseded by any provision in this order.
5. All the Magistrates, Police Officers, Officers of all Departments, PSUs, Organisations and Members and officials of Local Bodies shall ensure strict implementation of the Orders of SEC *ibid*.
6. Senior Superintendent of Police Chamba shall ensure to deploy ample police force for the setup of check posts-nakas at various strategic locations of the district and provide necessary assistance to concerned Sub Divisional Magistrates in execution of this order.

The compliance of this order shall be ensured by the Senior Superintendent of Police, Chamba, all the Sub Divisional Magistrate, Head of Departments, Executive Magistrates, Block Development Officers, PRIs, and Members of ULBs in Chamba District.

Violation of the order shall attract provisions of sections 188, 269 and 270 of IPC, relevant provision of Disaster Management Act, 2005 and HP Police Act, 2007 and the violator shall be prosecuted accordingly.

This order shall come into force with immediate effect in the entire territorial jurisdiction of Chamba District and shall remain valid till further orders.

ORDER

In continuation of SEC's Order dated 05.05.2021, taking into consideration the increase in incidence of COVID-19 cases and fatalities across the State, the undersigned, in the capacity of the Chairman (SEC), exercising the powers conferred under section 22(2)(h) and section 24 of the Disaster Management Act, 2005 hereby directs that the **following further restrictions shall be imposed in Himachal Pradesh w.e.f. 6 AM of 10th May 2021 to 6 AM of 17th May 2021:**

1. Operations of Public stage and contract carriages shall remain suspended during the period, except for essential services only.
2. Plying of private personal vehicles shall be allowed only for medical and other emergencies, including for the purpose of vaccination, testing and treatment for COVID-19. Private vehicles used for performance/delivery of essential, medical & public services shall also be allowed.
3. All shops shall remain closed, except those dealing with Public rations, daily needs and essential commodities such as food grains, groceries, fruits, vegetables, dairy products, meat & fish, animal feed, fodder, seeds, fertilizers & pesticides. Shops pertaining to construction material shall however now remain closed during the currency of these orders. The shops permitted above shall open for a limited period of 3 hours every day. However, this time limit shall not be applicable to pharmacies & medical/medicine shops. The District Magistrates shall prescribe the timing for their respective districts.

All other exemptions and restrictions shall continue to remain as per guidelines issued vide order dated 05.05.2021.

This Order shall remain in force, in all parts of the State for the period as aforementioned.
