**Subject:- Extension of Corona Curfew in District Jammu up to 7.00 AM on 31-05-2021 (Monday)**

**Order No: - 10/DCJ of 2021  
Dated:- 23-05-2021**

1. *Whereas*, vide this office Order Nos. 02/DCJ of 2021-22 dated 29-04-2021 Corona Curfew was imposed in the district with effect from 29.04.2021 which was further extended, vide order No's 03/DCJ of 2021 dated 01-05-2021, 05/DCJ of 2021 dated 05-05-2021, 06/DCJ of 2021 dated 09-05-2021 & 08/DCJ of 2021 dated 15-05-2021 up to 24-05-2021 (Monday, 07:00 AM);
2. *Whereas*, a detailed review of the current COVID situation was conducted by the District Disaster Management Authority (DDMA), Jammu with respect to current positivity rate, hospital bed occupancy and total active cases;
3. *And whereas*, on account of the above the District Disaster Management Authority (DDMA) is of the considered view that stringent containment measures are required to be taken at a macro level in order to restrict the movement and inter mingling of people, thereby limiting the chain of transmission;
4. Now, therefore, in exercise of powers conferred under section 34 of National Disaster Management Act, 2005, **I, Anshul Garg, IAS in my capacity as the Chairperson of District Disaster Management Authority, Jammu hereby order extension of Corona Curfew across the entire jurisdiction of Jammu District with effect from 7.00 AM on 24.05.2021 to 7.00 AM on 31.05.2021 (Monday).**

5. All activities and movements shall be permissible as per the guidelines detailed below: -

**(A). Permissible Activities in entire District**

- i. Chemists and Druggists (both retail and wholesale), Diagnostic Centres, Medical, optical and Clinical Establishments
- ii. LPG Outlets and Petrol Pumps
- iii. Agricultural activities including establishments dealing with agricultural inputs, implements and tools
- iv. Cattle feed and fodder shops
- v. Banks, ATMs and Cash Vans
- vi. Print and electronic media (on production of valid ID card/ pass)
- vii. FCI and FCS&CA depots
- viii. Operation and maintenance of telecom towers and other telecom infrastructure (on production of valid ID Card/ pass)
- ix. e-Commerce & Home Delivery of essential goods and services
- x. Restaurants in Hotels for in-house guests, to be served only in rooms
- xi. Kitchens in Restaurants and Food Outlets (only for Home Delivery) subject to production of valid permits
- xii. Dhabas/Eateries along National Highways outside Jammu Municipal Corporation (JMC) limits to cater to Truck drivers and cleaners
- xiii. All Industrial and Scientific establishments (both Public & Private)
- xiv. All development, construction works and mining activities
- xv. Service Stations, Automobile and Cycle Repair Shops, Welding shops, shops dealing with spare parts of Industrial Units & Mechanical Workshops
- xvi. Movement of all Health, Medical & Sanitation personnel (Both Government and Private) on production of ID cards
- xvii. Routine vaccination drive at all designated sites
- xviii. Interstate and intra state movement of essential goods
- xix. Officers and officials of UT Government, Govt of India, PSUs, Autonomous Bodies, Universities, All India Radio, Doordarshan and other such offices as per 50% attendance rosters formulated by concerned Head of the Departments

**(B). Partially Permissible Activities in entire District (6.00 AM to 11.00 AM)**

08.	Shops Dealing with repair of Electrical & Electronic Appliances	


**(C). Schedule for Inspection of Stocks (8.00 pm to 10.00 pm)**

Various categories of establishments shall be allowed a 2-hour window as per the following schedule only for inspection of stocks. However no commercial activity or transactions shall be carried during this time and violations shall attract penal provisions under DM Act: -

S. No.	Type of Establishment/ Shop	Day
01.	Boutiques & Cosmetic Shops	Wednesday
02.	Furniture Showrooms and Stores	Thursday
03.	Arms & Ammunition Shops Shops dealing with Sports equipment	Friday

6. All other instructions and SOPs issued by this office in this regard and not in contradiction to above, will continue to remain valid.

7. Any violation of the directions issued above shall invite penal action under the relevant provisions of Disaster Management Act, 2005. Since, it is not possible to serve prior notice of this order; it is as such being issued ex-parte.
