Whereas the Government of Maharashtra, in exercise of the power conferred under section 2, 3, & 4 of the Epidemic Diseases Act, 1897 has framed Regulations for prevention of containment of COVID-19 under Notification No. Corona 2020/CR/58/Aarogya-5 dated 13th March, 2020 and Dated 14<sup>th</sup> March, 2020.

And Whereas, as per rule 3 of the said Regulation, Municipal Commissioner of Municipal Corporation has been declared as 'Empowered officer' & is empowered to take such measures as are necessary to prevent the outbreak of Covid-19 or spread thereof within his respective jurisdiction,

Whereas, Government of Maharashtra vide its order dated 30<sup>th</sup> September 2020 and 14<sup>th</sup> October 2020 (extended by order dt. 29<sup>th</sup> October 2020, 27<sup>th</sup> November 2020, 29<sup>th</sup> December 2020, 29<sup>th</sup> January, 2021 and 24<sup>th</sup> February, 2021, 15<sup>th</sup> March, 2021, 17<sup>th</sup> March, 2021, 27<sup>th</sup> March, 2021, 4<sup>th</sup> April 2021, 5<sup>th</sup> April 2021, 13<sup>th</sup> April, 2021, 21<sup>st</sup> April 2021, 29<sup>th</sup> April 2021 and 12<sup>th</sup> May 2021) issued order for containment of COVID-19 in the State, for a period upto 7 AM on 1<sup>st</sup> June, 2021 and issued revised guidelines by




including certain activities from time to time vide above mentioned order and which is now further extended for a period upto till 7 AM on 15<sup>th</sup> June, 2021 vide its order dt. 30<sup>th</sup> May, 2021, as referred at Sr. No. 7.

Whereas, The positivity rate in Nagpur Municipal Corporation limit is less than 10% and the Occupancy of total oxygen beds available therein is less than 40%.

And therefore, in exercise of powers conferred under rule 3 of the "The Maharashtra COVID-19 Regulation, 2020" and of all other powers enabling in that behalf, in the interest of safety of life of public at large, I, Radhakrishnan B., Municipal Commissioner Nagpur Municipal Corporation hereby direct that the following relaxation to the order dt. 13<sup>th</sup> May 2021 (and any clarification/addition thereof) as referred at Sr. No. 6 issued by this office shall be applicable :-

- a) All essential Shops that are currently allowed to operate between 7 AM and 11 AM are now allowed to operate between 7 AM and 2 PM.
- b) In the case of all non-essential shops (stand-alone shops & not inside shopping centers/malls), such shops shall be allowed to operate between 7 AM and 2 PM during Monday to Friday.
- c) Post 3 PM there shall be restriction on movement except for Medical and other emergencies, or for home deliveries allowed under the order dated 13<sup>th</sup> May 2021.
- d) All Government offices, except those involved directly for corona work can function with 25% attendance in Nagpur City limits.
- e) Agriculture sector related shops shall remain open till 2 PM throughout the week.
- f) There are no restriction for cargo movements and deliveries to shops/establishments beyond the opening time of these are allowed for the purposes of replenishments of stock. There shall however be no serving of any customers beyond permitted times over the counter. Anyone breaking these orders shall be closed down till the period notification of Corona Pandemic is in operation in addition to fines mentioned in order dated 12<sup>th</sup> May 2021.
- g) Home Delivery through E-Commerce platforms (**Essential & Non-essential items**) will be permitted till 11.00 PM.

The said directions and guidelines issued by this office dt. 13<sup>th</sup> May, 2021 (and any clarification/addition thereof) shall be applicable along with new guidelines issued by Government of Maharashtra vide its Order dt. 30<sup>th</sup> May, 2021, with the same restrictions issued, for containment of Covid-19 Epidemic, in the City of Nagpur till 7 AM on 15<sup>th</sup> June, 2021 to Break the Chain of transmission effectively.


