AND WHEREAS under the Scheme, Registration Card is issued under The Building and Other Construction Workers (Regulation of Employment and Condition of Service.) Act, 1996 to provide Subsidised and Healthy Meal, Subsidised transport pass Assistance, Education Assistance, Maternity Assistance, Assistance in case of accidental death, funeral assistance etc. (hereinafter referred to as "the benefit") is given to the unregistered Building and Other Construction Workers (hereinafter referred to as "the beneficiaries"), by the implementing Agency as per the extant scheme guideline;

AND WHEREAS the aforesaid scheme involves recurring expenditure incurred from the consolidated Fund of state of Gujarat;

NOW, THEREFORE, in exercise of the powers conferred by section 7 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services), Act, 2016 (18 of 2016) (hereinafter referred to as the said Act), the Government of Gujarat hereby notifies the following, namely:-

1. (1) An Individuals eligible for receiving the benefits under the scheme shall hereby be required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication.

(2) Any individual desirous of availing benefits under the scheme, who does not Possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrolment before registering for the scheme provided that he is entitled to obtain Aadhaar as per section 3 of the said act and such individuals shall visit any Aadhaar enrolment centre (list available at the Unique Identification Authority of India (UIDAI) website www.uidai.gov.in) to get enrolled for Aadhaar.


