following amendment in the Government notification No. CCT/26-2/2018-19/64/1825, dated the 25th November, 2020, published in the Official Gazette, Extraordinary, Series II No. 35, dated the 26th November, 2020, namely:—

In the said notification, after the proviso, the following proviso shall be inserted, namely:—

“Provided further that the time limit for furnishing the details of outward supplies in FORM GSTR-1 of the said rules for the registered persons required to furnish return under sub-section (1) of Section 39 of the said Act, for the tax period April, 2021, shall be extended till the twenty-sixth day of the month succeeding the said tax period.”

Order

No. 27/6/2021-I/PHD/1014

Reference Order dated 30-04-2021 of the Hon. Supreme Court in Suo Motu Writ Petition (Civil) No. 3/2021, wherein it has been observed that as the RTPCR COVID-19 testing facilities are overwhelmed and test results are taking inordinate long time, and at times, the results are inaccurate. In such circumstances, the patients are refused service on various grounds. Some patients are denied

admissions for lack of valid ID card and place of residence.

Now, the State Government in exercise of Section 2(1) of the Epidemic Diseases Act, 1897, hereby issues following directions for strict compliance:—

(1) No patient requiring critical care or emergency service shall be turned away or denied service/admission in any Hospital for want of RTPCR Certificate.

(2) No patient shall be denied medical service or admission in any Hospital for want of ID proof or for the fact that he is not a resident of the city or State where the Hospital is located.

(3) The admission to the Hospital must be based on need and considering the scarcity of beds, only need based patients shall be admitted in Hospital after proper clinical assessment by medical experts.

The above directions/instructions shall be scrupulously followed and any deviation from the same shall attract penal action as per law.

As per the approval of the Council of Ministers conveyed by General Administration Department vide letter No. 1/10/2021-GAD-II dated 07-05-2021, the following persons are hereby declared as 'Frontline Workers' for the purpose of vaccination

who are contributing to the fight against COVID-19 on a daily basis by being at the forefront and are thus, at risk of contracting the disease in furtherance of their duties:—

1. State Government employees as certified by the respective Heads of Departments or any officer authorized to certify by them.

2. Central Government employees as certified by the respective Heads of Departments or any Officer authorized to certify by them.

3. All employees of Autonomous/Semi Government/PSUs of Central Government or State Government as certified by their respective Heads of Departments or any Officer authorized to certify by them.

4. Accredited Journalists and other media Personnel as certified by Department of Information & Publicity or any Officer authorized to certify by him/her.

5. Employees of Banking Institutions as certified by their employer.

6. Employees/Workers of Homes for Children/ /disabled/Mentally challenged/Senior Citizens/ /Destitutes/Women/Widows/etc. as certified by Director of Women and Child Development or Director of Social Welfare or any Officer authorized to certify by them.

7. Employees/Workers engaged in provision of Telecommunication and Internet services as certified by Director, Information Technology or any Officer authorized to certify by him/her.
