Subject: Measures for functionalization of Covid vaccination site at ESIC/ESIS Hospitals/dispensaries/Special camps for ESI beneficiaries.

Sir/Madam,

References are being received from various trade Unions/Organizations/members of ESI Corporations for running special Covid vaccination drive for ESI beneficiaries and their family members. At present, Govt. of India is providing Covid vaccines to the States, which in turn are finalizing Covid vaccination sites. Under the current arrangement, Covid vaccination facility is not available at certain number of ESIC/ESIS hospitals and dispensaries.

In this regard, the competent authority has decided as under :-

- All Regional Directors to coordinate with State Governments so as to ensure adequate allocation of Covid vaccines to ESI system. Logistics, maintenance of cold chain and other related issues are also to be duly addressed by RDs.
- Regional Directors/MSs of ESIC/ESIS Hospitals/DIMS to expedite functionalization of Covid vaccination facility in all ESIC/ESIS Hospitals and dispensaries.
- ESIC/ESIS medical manpower is to be optimally utilized for running Covid vaccination facilities so that ESI beneficiary are vaccinated in a hassle free and time bound manner.
- RDs to identify suitable Employee's locations/IPs working sites and organize special Covid vaccination camps duly utilizing ESIC/ESIS medical manpower in association with DIMS and MSs/Dispensary In-charge of nearest ESIC/ESIS Hospital/Dispensary.

In view of above, requisite actions are to be taken by all concerned for smooth conduction of Covid vaccination services in ESI system in the interest of IPs.

This issues with the approval of competent authority.
