Sub: Phased Programme for Implementation of ESI Scheme for year 2021-22.

Sir,

Kindly refer to Letter No.X-11/14/03/2017-P&D dated 14.10.2020 on the above cited subject wherein the district wise Phased Programme of Implementation for the year 2020-21 was conveyed as per Vision - 2022. The targets for 2020-21 could not be achieved due to non-completion of medical arrangement during the COVID pandemic. Now, a new consolidated target for 2021-22 is enclosed which includes the pending districts not notified during the year 2020-21 in the target of notification.

The present status of notification is that the entire area of 400 Districts are fully notified, and in 183 districts, the Scheme is notified in the Districts Headquarters area or prominent Industrial centers. The Scheme is not-notified in 153 Districts.

It is also to inform that the Code on Social security, 2020 (Act 36 of 2020) has been notified. The effective date of implementation is also expected to be notified shortly. The code subsumes ESI Act, 1948 along with eight other central enactments in the field of Social Security. Once notified, the entire area of the country shall be implemented for the purposes of ESI Scheme. Therefore, it is imperative to make medical arrangement in all areas within this financial year itself.

The targets for the year 2021-22 are enclosed as Annexure -A with the request that necessary steps may be taken on priority for implementing the scheme in the districts shown in the Annexure.

In view of the above, the State Govt. is requested to take steps to complete the medical arrangement in the districts for delivery of medical care to the Insured Persons and their family members so as to enable ESIC to take further action for issue of notification well in time for implementing the Scheme.

2. The Regional Director, ESI Corporation,..... for pursuing the matter with the State Government for speeding up implementation of scheme as per phased programme. Regional Director may monitor personally the submission of medical benefit arrangement plan both by the State Government and from the Regional Office itself as per targets fixed and discuss at the highest level so that the targets could be achieved. The phased programme and achievement of the targets may be discussed in the Regional Board & SEC Meetings. For the areas falling in the jurisdiction of Sub Regional Offices/Divisional Offices, Regional Director may ensure medical arrangement and Branch Office availability in the new area. DCBO has also been sanctioned for various districts which are to be run by ESIC directly. Opening of DCBO/mIMP empanelment may be linked to phased programme of implementation, especially in respect of those States where NOC for making medical arrangement has been given by the State Govt. to ESIC.

विषय : वर्ष 2021-22 के लिए क.रा.बी. योजना के कार्यान्वयन के लिए चरणबद्ध कार्यक्रम।

महोदय,

कृपया उपर्युक्त विषय पर पत्र संख्या एक्स-11/14/03/2017-यो. एवं वि., दिनांक 14.10.2020 का संदर्भ लें जिसके द्वारा विजन-2022 के अनुसार वर्ष 2020-21 के लिए जिलावार चरणबद्ध कार्यक्रम सूचित किया गया। वर्ष 2020-21 के लक्ष्य कोविड-19 महामारी के दौरान चिकित्सा सुविधा उपलब्ध न होने के कारण पूरे नहीं किए जा सके। अब 2021-22 के दौरान कार्यान्वयन के लक्ष्य जो वर्ष 2020-21 के दौरान पूरे नहीं किए गए लंबित जिलों को सम्मिलित कर एक नया समेकित लक्ष्य संलग्न किया गया है।

कार्यान्वयन की वर्तमान स्थिति यह है कि 400 जिले पूर्णतः अधिसूचित हो चुके हैं और 183 जिलों में योजना को जिला मुख्यालय क्षेत्र अथवा प्रमुख औद्योगिक केंद्रों में अधिसूचित किया जा चुका है। योजना को 153 जिलों में अधिसूचित नहीं किया गया है।

यह भी सूचित किया जाता है कि सामाजिक सुरक्षा संहिता (वर्ष 2020 का अधिनियम 36) को अधिसूचित किया जा चुका है। कार्यान्वयन की प्रभावी तिथि भी शीघ्र अधिसूचित की जानी अपेक्षित है। संहिता में सामाजिक सुरक्षा क्षेत्र के आठ अन्य केंद्रीय विधानों सहित क.रा.बी. अधिनियम 1948 भी सम्मिलित है। अधिसूचित होने पर, देश के संपूर्ण क्षेत्र को क.रा.बी. योजना के उद्देश्य के लिए कार्यान्वित किया जाएगा। अतः इस वित्तीय वर्ष के भीतर सभी क्षेत्रों में स्वयं चिकित्सा व्यवस्था करना अनिवार्य है।

वर्ष 2021-22 हेतु योजना के कार्यान्वयन के लिए जिला-वार लक्ष्य संलग्नक-A में इस निवेदन के साथ संलग्न है कि संलग्नक में दर्शाए जिलों में योजना के कार्यान्वयन के लिए प्राथमिकता के आधार पर आवश्यक कदम उठाए जाएं।

उपर्युक्त को देखते हुए, राज्य सरकार से अनुरोध है कि लक्ष्य तिथि से पहले बीमाकृत व्यक्तियों और उनके परिवार के सदस्यों को चिकित्सा देखरेख की आपूर्ति हेतु जिलों में आवश्यक चिकित्सा व्यवस्था पूरी करने के लिए कदम उठाए ताकि समय-सीमा के अनुसार योजना के कार्यान्वयन हेतु समय पर अधिसूचना जारी करने के लिए क.रा.बी. निगम आगे की कार्रवाई कर सके।



2. क्षेत्रीय निदेशक, क.रा.बी.निगम को चरणबद्ध कार्यक्रम के अनुसार योजना के कार्यान्वयन में तेजी लाने के लिए राज्य सरकार के साथ मामले को आगे बढ़ाने हेतु। निर्धारित लक्ष्यों के अनुसार राज्य सरकार और स्वयं क्षेत्रीय कार्यालय द्वारा प्रस्तुत चिकित्सा हितलाभ व्यवस्था योजना की निगरानी क्षेत्रीय निदेशक द्वारा व्यक्तिगत स्तर पर की जाए और उच्चतम स्तर पर इसकी चर्चा हो ताकि लक्ष्यों को प्राप्त किया जा सके। चरणबद्ध कार्यक्रम और लक्ष्यों की प्राप्ति के बारे में क्षेत्रीय बोर्ड और एस.इ.सी. की बैठकों में चर्चा की जाए। यह उप क्षेत्रीय कार्यालयों/प्रभागीय कार्यालयों के क्षेत्राधिकार में आने वाले क्षेत्रों के लिए है। क्षेत्रीय निदेशक नए क्षेत्र में चिकित्सा व्यवस्था और शाखा कार्यालय की उपलब्धता सुनिश्चित करें। औषधालय-सह-शाखा कार्यालय को भी विभिन्न जिलों के लिए मंजूर किया गया है जिसे सीधे क.रा.बी.निगम द्वारा संचालित किया जाएगा। औषधालय-सह-शाखा कार्यालय/mIMP empanelment खोलने को कार्यान्वयन के चरणबद्ध कार्यक्रम से जोड़ दिया जाए, विशेषकर उन राज्यों के संबंध में जहां चिकित्सा व्यवस्था के लिए क.रा.बी.निगम को अनापत्ति प्रमाणपत्र राज्य सरकार द्वारा दिया गया है।
3. बीमांकन शाखा/वित्त एवं लेखा शाखा/ चिकित्सा-I/चिकित्सा-II/स्था-III को सूचनार्थ।
4. उप निदेशक (जनसंपर्क), क.रा.बी.निगम, मुख्यालय को इसे मुख्यालय की वेबसाइट पर अपलोड करने के अनुरोध के साथ।
