
## ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT-2005

In compliance to the order no. Rev(DMC) (C) 20-2/2020-COVID 19, Dated 24<sup>th</sup> August, 2021, issued by worthy Chief Secretary cum Chairperson, State Executive Committee, Himachal Pradesh and in continuation to this office order no. 3496 SK/DM, Dated 12<sup>th</sup> August, 2021, I, Dr. Nipun Jindal, District Magistrate, Kangra in exercise of the powers vested in me under section 34 of the Disaster Management Act, 2005, do hereby order and direct that:

1. All schools shall continue to remain close, except residential schools further up to 04.09.2021. Teaching and non-teaching staff shall continue to attend the school. However residential schools are permitted to remain open subject to strict adherence with SOPs developed by the Department of Education to contain the spread of COVID-19.
2. All social/ academic/ entertainment/ cultural/ political/ religious and other congregations are permitted up to 50% of the capacity in indoor built up covered areas as well as in open spaces. These restrictions are subject to strict adherence with COVID-19 appropriate behavioural norms and social distancing. Wearing of face masks, maintaining social distance, provision of thermal scanning and use of hand wash or sanitizer shall be mandatory at all such venues.

COMPLIANCE to this order shall be ensured by Superintendent of Police Kangra, all Sub Divisional Magistrates, Executive Magistrates, Chief Medical Officer in District Kangra. Any obstruction, resistance or refusal by any officer, official or any other person to comply with the directions as aforesaid shall render such person liable to prosecution under sections 51 to 60 of Disaster Management Act, 2005.


