The following Bill was introduced in the Maharashtra Legislative Assembly on the 22nd December, 2021 is published under Rule 117 of the Maharashtra Legislative Assembly Rules:—

A BILL

further to amend the Mumbai Municipal Corporation Act.

WHEREAS both Houses of the State Legislature were not in session;

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take III of immediate action further to amend the Mumbai Municipal Corporation Act, 1888. Mah. for the purpose hereinafter appearing; and, therefore, promulgated the Ord. Mumbai Municipal Corporation (Second Amendment) Ordinance, 2021 on XIII of 2021.

AND WHEREAS it is expedient to replace the said Ordinance by an Act of the State Legislature; it is hereby enacted in the Seventy-second Year of the Republic of India as follows:—

Short title and commencement.

- 1. (1) This Act may be called the Mumbai Municipal Corporation (Second Amendment) Act, 2021.
 - (2) It shall be deemed to have come into force on the 30th November 2021.

Amendment of section 5 of III of 1888.

2. In section 5 of the Mumbai Municipal Corporation Act (hereinafter III of referred to as "the principal Act"), in sub-section (*I*), in clause (*a*), for the words "two hundred and twenty-seven" the words "two hundred and thirty-six" shall be substituted.

Repeal of Mah. Ord. XIII of 2021 and saving. **3.** (1) The Mumbai Municipal Corporation (Second Amendment) Mah. Ordinance, 2021, is hereby repealed.

Mah. Ord. XIII of 2021.

(2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the corresponding provisions of the principal Act, as amended by the said Ordinance, shall be deemed to have been done, taken or, as the case may be, issued under the corresponding provisions of the principal Act, as amended by this Act.

STATEMENT OF OBJECTS AND REASONS

Section 5 of the Mumbai Municipal Corporation Act (III of 1888) provides the number of Councillors directly elected at ward elections in Municipal Corporation of *Brihan* Mumbai. The existing number of directly elected Councillors are based upon the population figures of 2001. After the Census of 2011, the number of directly elected Councillors were not changed.

- 2. As per the population data of 2011 Census in the decade of 2001 to 2011, there is growth of 3.87 per cent. in the population in the limits of the Municipal Corporation of *Brihan* Mumbai. Considering this growth in urban population and the growing speed of urbanization, to ensure that the increased population to be proportionately represented in the Corporation, it was considered expedient to enhance the number of directly elected Councillors in the Municipal Corporation of *Brihan* Mumbai. It was, therefore, proposed to amend section 5 of the Mumbai Municipal Corporation Act, suitably.
- 3. As both Houses of the State Legislature were not in session and the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action further to amend the Mumbai Municipal Corporation Act, for the purpose aforesaid, the Mumbai Municipal Corporation (Second Amendment) Ordinance, 2021 (Mah. Ord. XIII of 2021), was promulgated by the Governor of Maharashtra on the 30th November 2021.
- 4. The Bill is intended to replace the said Ordinance by an Act of the State Legislature.
