- 1. Whereas, the Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 had issued order dated 27.12.2021 regarding implementation and compliance of guidelines and National Directives for Covid 19 Management in view of reported increase of infection by the highly mutant Covid-19 variant B.1.1529 (OMICRON) in the country.
- 2. Whereas, reports regarding likelihood of people gathering in large numbers for celebratory programme has been received.
- 3. Now, therefore, the undersigned, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 in his capacity as Chairperson, of the State Executive Committee of the State Disaster Management Authority, hereby orders restriction of the following activities:
 - Music concerts.
 - II. Thabal Chongba.
 - III. Celebratory feasts.
 - IV. Large gathering of people in enclosed areas or indoor halls.
 - NIGHT CURFEW to be imposed FROM 9 PM to 4 AM, with exemption for essential services and medical emergencies.
- 4. Wearing of face masks in public places, gatherings and crowded areas is a critical Covid Appropriate Behaviour and it should be strictly enforced and violators to be penalised promptly under relevant rules.
- All District Magistrates shall strictly enforce the above restrictions by invoking relevant provisions of law.
- 6. This order is in continuation of the order of even number dated 27.12.2021 and shall remain in force till 31.01.2022.
