ORDER

Whereas, the Delhi Disaster Management Authority (DDMA) is satisfied that the NCT of Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization, and has considered it necessary to take effective measures to prevent its spread in NCT of Delhi.

And whereas, Delhi Disaster Management Authority has issued various orders/instructions from time to time to all authorities concerned to take all required measures to appropriately deal with the situation.

And whereas, DDMA order No. F.60/DDMA/COVID-19/2021/500 dated 28.12.2021 has emphasised that the permitted/prohibited/restricted activities shall be as specified at Level-1 (Yellow) in DDMA order No. 460 dated 08.08.2021 enclosed with this order (Annexure-1) with immediate effect till further orders. As per the GRAP for compliance & enforcement Covid Appropriate Behaviour for market area it has been directed to ensure that the public who visit such markets strictly follow Covid Appropriate Behaviour and wear masks, maintain social distancing etc. without fail. If the aforesaid norms of COVID Appropriate Behaviour are not maintained at any establishment/business premises/mall/market or any other places, then such premises /mall/market/weekly market etc. shall be liable to be closed for containing the spread of COVID-19 virus and the defaulter/owner of the establishment etc. shall also be liable for criminal prosecution under the relevant laws.

Regarding weekly markets the DDMA order directs that no weekly market shall be allowed to function on roadsides. The weekly markets can be allowed to function at suitable nearby grounds/school grounds, where the SOP/guidelines of DDMA can be strictly implemented. In case it is found that COVID Appropriate Behaviour or prescribed SOPs/Guidelines are not being followed in weekly Markets and / or the positivity rate, Number of covid-19 positive persons, growth rate etc. start increasing in NCT of Delhi then all Weekly Market shall be closed forthwith.

market received that information was Whereas, thiyawallahs/Vendors, and general Public in Sonia Vihar 41/2 Pusta Shani Market Block-E and Johripur Shani Market Road Karawal Nagar are not following the Covid Appropriate Behaviour. The guidelines/directions of COVID Protocol are being contravened in the Sonia Vihar 41/2 Pusta Shani Market Block-E and Johripur Shani Market Road Karawal Nagar which may cause super-spreading of the Corona Virus. In this spread of the COVID-19 and its new variant OMICRON and where requested to ensure compliance of COVID Appropriate Behaviour (CAB). There were asked to display the following signboards on the shops/establishments/offices in the market:- (i) "No- Mask, No- Entry", (ii)" Please keep social distancing (6- Feet)" and (iii) " Use sanitizers". They were also asked to open the shops on Odd-even basis, i.e. shops would open an alternative days.

Whereas, in the above mentioned scenario, it is necessary to take an immediate and stringent action to curtail the spread of the virus and not to let develop any such public. interest larger spreader super place

Now, therefore, I Sanjay Sondhi, Incident Commander, Sub Division: Karawal * Nagar, under DDMA Act, 2005 in exercise of the powers conferred under Act/Regulations mentioned above and in overall imminent public interest, do hereby order that the Sonia Vihar 41/2 Pusta Shani Market Block-E and Johripur Shani Market Road Karawal Nagar are hereby closed with effect from 4.00 PM on 01.01.2022 till 10:00 AM on 02.01.2022 or till further orders, whichever is earlier. These restrictions are applicable except shops dealing with essential goods and services.

In the event of any shopkeeper found violating this order or any act which many spread COVID-19, necessary action as per law would be taken against him/her under Section 51 to 60 of Disaster Management Act, 2005, Section 188 of IPC and other relevant applicable Acts.

Further the ACP, Khajuri Khas is directed to ensure strict compliance of this order properly. The Market Welfare Association is also directed to extend all its cooperation in this regard.
