Sub:- Restrictions for Containment in District Reasi w.e.f. 07-01-2022.

Order No: 03-DC (Rsi) of 2022

Dated:- 07-01-2022

Whereas, State Executive Committee vide order No. 01-JK(DMRRR) of 2022 dated 02-01-2022 issued under endorsement No. DMRRR/PS/Secy/551/2020 dated 02-01-2022 has interalia instructed that:-

1. The District Magistrates of J&K shall strictly ensure that there is full compliance to Covid Appropriate Behaviour and defaulters are firmly dealt with under relevant sections of the Disaster Management Act and the Indian Penal Code.
2. The District Magistrates shall intensify testing and ensure full utilization of available RT-PCT and RAT capacities.
3. The District Magistrates shall also focus on the positivity rates of the Medical-Blocks under their jurisdictions. Intensified measures related to Covid management and restriction of activities shall be undertaken in these Blocks.
4. The three- "T" protocol of testing, tracking and treating, besides vaccination, needs to be strengthened in all Blocks.
5. Positive cases detected because of intensive testing to be isolated/quarantined at the earliest and their contacts shall also be traced and similarly isolated/quarantined and tested if needed.

Whereas, State Executive Committee vide order No. 02-JK(DMRRR) of 2022 dated 05-01-2022 issued under endorsement No. DMRRR/PS/Secy/551/2020 dated 05-01-2022 has ordered that there shall be a complete restriction on non-essential movement in the entire UT of J&K from 9:00PM to 6:00AM till further orders; and

Whereas, due to exponential spike of Covid cases in District Reasi during the last few days, it has been found expedient to impose certain restrictions to contain the further spread of Covid-19 cases.

Now, therefore, in exercise of the powers vested in me under National Disaster Management Act, 2005 and Epidemic Diseases Act 1897, **I, Charandeep Singh, JKAS, District Magistrate, Reasi & Chairman, District Disaster Management Authority** do hereby order that there shall be a complete restriction on non-essential movement in the entire jurisdiction of District Reasi from **9:00 PM to 6:00 AM**.

However keeping in view Yatra to Shri Mata Vaishno Devi Shrine/Shri Shiv Khori Shrine, it is further ordered that:-

All **Dhabas/Restaurants/Eating Points** falling within the jurisdiction of Municipal Limits of Katra & village Ransoo shall remain operational from **6:00 AM to 11:00 PM**.

There shall be no restrictions on the movement of yatris to Shri Mata Vaishno Devi Shrine/Shri Shiv Khori Shrine.

Since it is not possible to serve prior notice of this order, it is as such being issued ex-parte.

Any violation of this order shall invite punitive action under section 188 of Indian Penal Code and other relevant sections of Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005. This order shall be widely circulated for information of all by the District Information/Informatics Officer Reasi.

Senior Superintendent of Police Reasi shall implement this order in letter & spirit.
