H.P. ORDINANCE NO. 1 of 2022

**THE HIMACHAL PRADESH MUNICIPAL CORPORATION (AMENDMENT)
ORDINANCE, 2022**

Promulgated by the Governor of Himachal Pradesh in the Seventy-third Year of the Republic of India.

AN ORDINANCE further to amend the Himachal Pradesh Municipal Corporation Act, 1994 (Act No. 13 of 1994).

WHEREAS, the Legislative Assembly of Himachal Pradesh is not in session and the Governor of Himachal Pradesh is satisfied that circumstances exist which render it necessary for him take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Clause(1) of Article 213 of the Constitution of India, the Governor of Himachal Pradesh is pleased to promulgate the following Ordinance:—

1. Short title.—This Ordinance may be called the Himachal Pradesh Municipal Corporation (Amendment) Ordinance, 2022.

2. Amendment of section 6.—In Section 6 of Himachal Pradesh Municipal Corporation Act, 1994, in clause (a), in the proviso, for the words “thirty seven”, the words “forty one” shall be substituted.
