
**ORDER.**

Pursuant to the modified Covid-19 protocols issued by the Government of Meghalaya Home (Political) Department, Meghalaya, Shillong vide order No. POL.75/2020/Pt.I/122 dated 11<sup>th</sup> February, 2022, the following order is given in North Garo Hills District with immediate effect.

1. All persons entering the State, who are fully vaccinated will not be required to undergo RTPCR test at the COVID Screening Centres.  
All others have to produce an RTPCR negative report valid for 72 hours prior to arrival at the Covid Screening Centre at the entry points or have to undergo a mandatory RTPCR test at the entry points. For those being tested at the Covid Screening Centre at the entry points, it is mandatory to be isolated till the receipt of the report.  
Children below 15 years of age do not have to produce RTPCR negative report or undergo testing at Covid Screening Centres unless they are symptomatic.
2. Night Curfew imposed earlier is lifted.
3. Only fully vaccinated persons are permitted entry into restaurants/bars/clubs.
4. All persons should follow Covid appropriate behavior including wearing of masks in public places, maintaining social distancing.

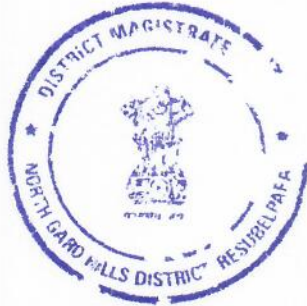
