Whereas the draft Rules of the Goa Panchayat and Zilla Panchayat (Election Procedure) (Seventh Amendment) Rules, 2021 was pre-published as required by sub-

section (1) of section 240 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994) in the Official Gazette, Series I No. 41 dated 6th January, 2022 under Notification No. 34/DP/PAN/ZP/2021/8878 dated 31-12-2021 of the Department of Panchayat Raj and Community Development, inviting objections and suggestions from all persons likely to be affected thereby before the expiry of fifteen days from the date of publication of the Notification in the Official Gazette.

And whereas the said Gazette was made available to the public on 06-01-2022.

And whereas no objections/suggestions have been received from the public on the said draft by the Government.

Now, therefore, in exercise of the powers conferred by section 15 and sub-section (2) of section 125 read with sub-section (1) of section 240 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), the Government of Goa hereby makes the following rules so as to further amend the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996 namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Panchayat and Zilla Panchayat (Election Procedure) (Seventh Amendment) Rules, 2021.

(2) They shall come into force on the date of their final publication in the Official Gazette.

2. *Amendment of rule 3.*— In the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996 (hereinafter referred to as the “principal Rules”), in rule 3,—

(i) in sub-rule (2), for the word “Director”, the words “State Election Commission in consultation with the Government” shall be substituted;

(ii) in sub-rule (4), for the word “Government”, the words “State Election Commission in consultation with the Government” shall be substituted.

3. *Substitution of Forms.*— In the principal rules, for the existing Form No. 10 and Form No. 11, the following forms shall be respectively substituted, namely:—

26/DP/PAN/Schedule-III/Rules/2021/766

In exercise of the powers conferred by section 241 of the Goa Panchayat Raj Act, 1994 (Goa Act No. 14 of 1994) (hereinafter referred to as the “said Act”) and all other powers enabling it in this behalf, the Government of Goa hereby amends the Schedule III appended to the said Act as follows, namely:—

In Schedule III appended to the said Act,- for the existing entries at serial numbers ‘A’ to ‘G’, the following entries shall be respectively substituted, namely:—
