## **NOTIFICATION**

Whereas, the Government of Telangana, in G.O.Rt.No.406, Labour Employment Training and Factories (Lab-II) Department, Dated:09.08.2021 has declared the Motor Transport Industry in the Telangana as a Public Utility Service for the purpose of Industrial Dispute Act, 1947 (Central Act 14 of 1947) for a period of six months with effect from **23.08.2021**.

- 2. Whereas the said period of six months will expire by **22.02.2022**.
- 3. And whereas, the Government of Telangana, is satisfied that it is necessary to declare the said industry as Public Utility Service for a further period of six months in public interest.
- 4. Now therefore, in exercise of the powers conferred by sub clause (VI) of clause (n) of Section 2 of the Industrial Dispute Act, 1947 (Central Act 14 of 1947), Government of Telangana hereby declares the Motor Transport Industry in the State of Telangana as a Public Utility Service Unit for a further period of six months with effect from **23.02.2022**, since the industry is specified in 1<sup>st</sup> schedule of Industrial Dispute Act, 1947.
