In exercise of the powers conferred on me under Section 112 of the Motor Vehicles Act, 1988 and Rule 264A of the Motor Vehicles Rules, 1991 as amended in 2005 and as recommended by the Dy. Superintendent of Police (Traffic), North, Altinho-Goa, I, Ajit Roy, IAS, District Magistrate, North Goa hereby notify "Speed Breakers" on the internal road at the place mentioned in Column No. 2 of the schedule below in the jurisdiction of Village Panchayat Guirim in Bardez Taluka.

The above Speed Breakers and Thick Rumbler Strips shall be painted with white thermoplastic fluorescent paint and fixed with blinkers for better visibility.

Further, in exercise of the powers conferred on me under Section 116 of the above Act, I also authorize the erection of cautionary signboards "Speed Breaker Ahead" at about 40 mts. on the left side of the road at the placement of the Speed Breaker & Rumbler Strips in order to regulate the motor vehicular traffic.

The Secretary Village Panchayat Guirim, Bardez is directed to publish this notification through the Director of Information and Publicity in newspapers and P.W.D to make necessary arrangements to erect the signboards at the places indicated above as per the specification laid down by the Ministry of Road Transport and Highways and as published in the Official Gazette by the Government of Goa and report compliance within thirty days time.

2) Letter No. DYSP/TRF/NORTH/183/2022 dated 16-02-2022 from the Dy. Supdt. of Police Traffic (North), Panaji.

Whereas, the Executive Engineer, WD XIII(R), PWD, Mapusa-Goa, vide letter referred at Sr. No. (1) has requested for diversion of road for urgent reconstruction of culvert along S.H. No. 1, near Assonora Sports Complex in Village Panchayat Assonora for the period of 60 days from the date of demolition of the existing old culvert.

And whereas, the DYSP Traffic (N), Altinho, PWD Panaji has recommended for reconstruction of the culvert in two parts i.e. half the culvert to be reconstructed and half portion of the road be allowed for one way vehicular traffic proceeding from Assonora to Mapusa side and after completion of the said half culvert, other portion of the culvert to be constructed and one way vehicular traffic proceeding from Assonora to Mapusa side be allowed to proceed on newly constructed half portion of culvert. The DYSP Traffic has further proposed that diversion of road from Cansa Thivim via Moitem Advalpal to Par Bridge Assonora to be provided for one way vehicular traffic proceeding from Mapusa towards Assonora side and the vehicular traffic proceeding from Assonora towards Mapusa side will be allowed to utilize the same S.H. No. 1.

Now therefore, in exercise of the powers conferred on me under Sections 115 & 116 of the Motor Vehicles Act, 1988, and as recommended by the Dy. Superintendent of Police (Traffic), Altinho Panaji I, Ajit Roy, IAS, District Magistrate, North Goa hereby order re-construction of the culvert in two parts i.e. half the culvert shall be re-constructed and half portion of the road shall be allowed for One Way vehicular traffic proceeding from Assonora to Mapusa side and after completion of the said half culvert, other portion of the culvert shall be constructed and One Way vehicular traffic proceeding from Assonora to Mapusa side shall proceed on newly constructed half portion of culvert. Further the diversion of road from Cansa Thivim via Moitem Advalpal to Par Bridge Assonora shall be provided for one way vehicular traffic proceeding from Mapusa towards Assonora side and the vehicular traffic proceeding from Assonora towards Mapusa side shall utilize the same S.H. No. 1 for a period of 60 days (i.e. from the date of demolition of the existing old culvert).

The Executive Engineer, WD XIII(R), PWD, Mapusa-Goa is directed to publish this Order through the Director of Information and Publicity in press/media/social media regarding the traffic diversion and to make necessary arrangements to erect the signboards at the required places and report compliance within fifteen days time.

#### Conditions

1. The normal flow of the vehicular traffic on the parallel and surrounding roads should not be obstructed.
2. The contractor shall deploy maximum Traffic Marshals round the clock for guiding the motorists/regulating vehicular traffic during

construction work and to ensure No Parking on main road and on foot path.

3. The contractor shall install red lamps/lights at the construction site for clear visibility during night time.
4. No construction material should be dumped on the road causing obstruction to the road users and motorists.
5. Sufficient traffic signages/directional boards regarding closure at all diversion points for the information of motorists and other road users.
6. The contractor undertaking the work, before blocking the approach road to any house or colony, shall construct temporary pathway to allow to and fro movement of the vehicles of the residents.
7. Wherever across road cutting is taken up, the work should be carried out one side of the road at a time to allow normal vehicular flow on remaining portion of the road.
8. After completion of the work entire place should be cleaned from all types of debris, mud etc. and the road should be brought down to its normalcy for the use of motorists and other road users.
9. The contractor shall give notice through Press/Media regarding closure and diversion of the road on receipt of this Order for the information of the motorists and other road users.
10. Prior permission from other competent authorities should be obtained in advance.
11. Material used for barricading the road should be painted/pasted with fluorescent paint/tape for illuminating the same during the night time.
12. The work should be completed within stipulated period of time and the roads shall be made free vehicular flow after resurfacing the same.
13. NOC from concerned Police Station should be obtained.
14. The contact number of the Contractor/Supervisor or the responsible person should be displayed at all closure/diversion points so as to enable him/her to contact if any emergent situation arises.
15. This permission is subject to cancellation/revocation at any moment.
