Subject: Auto-generated Exemption Certificate of White Category as per revised Classification of Industrial Sector (UCM) - BRAP 2022 and EodB / RCB -Action Plan compliance - reg.

All the Industrial units / project falling under White Category as per the revised classification of industrial sector issued by the CPCB, and subsequently adopted by the J&K PCC are covered under Uniform Consent Management, appended as Annexure A. There is no necessity of obtaining the consent for White Category of Industries as per revised classification of Industrial Sector and an intimation to the JKPCC shall suffice.

In pursuance to implementation of BRAP 2022 under Ease of Doing Business and further DPIIT, Ministry of Industries and Commerce, Government of India initiative of Reduce Compliance Burden (RCB), the JK PCC has simplified the procedure with regard to e Autogenerated exemption certificate of White Category of Industries.

In this regard, the industry / project proponent intending to seek auto-generated exemption certificate for White Category shall apply through ikocmms.nic.in. by filing an e-application form along with online undertaking / self-declaration certifying that the activity falls under white category of UCM classification and there shall be no trade effluent generation and discharge from the industry and industry is non-polluting as per the White Category index score mentioned in the revised classification of industrial sector issued by CPCB, and no fee is required to be deposited.

This free of cost facility is created for the Ease of doing Business and reducing the compliance burden as per the RCB Action Plan 2022 and Business Reforms Action Plan 2022.
