DRAFT AMENDMENT TO THE TAMIL NADU MOTOR VEHICLES RULES, 1989.

The following draft amendment to the Tamil Nadu Motor Vehicles Rules, 1989, which is proposed to be made in exercise of the powers conferred by sections 65 and 211 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), is hereby published for information of all persons likely to be affected thereby, as required by sub-section (1) of section 212 of the said Act.

(2) Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of seven days from the date of publication of this Notification in the issue of *Tamil Nadu Government Gazette* Extraordinary and that any objection or suggestion, which may be received from any person with respect hereto, before the expiry of the aforesaid period, will be considered by the Government of Tamil Nadu.

(3) Objection or suggestion, if any, should be addressed in duplicate to the Additional Chief Secretary to Government, Home Department, Chennai-9.
