No. ERTS (T) 65/2017/Pt III/310 - In exercise of the powers conferred by clause (ii) of Section 17 of the Meghalaya Goods and Services Tax (Amendment) Ordinance, 2022, the Government of Meghalaya on the recommendation of the Council, hereby makes the following further amendment in the notification No. ERTS(T) 65/2017/20 dated 29.6.2017 published in the Gazette of Meghalaya, Extraordinary, Part II No 107 dated 5.7.2017:

In the said notification, in paragraph 1 for the words “furnishing of returns and computation and settlement of integrated tax”, the following shall be substituted, namely:-

“furnishing of returns and computation and settlement of integrated tax and save as otherwise provided in the notification No. 69/2019 dated 13.12.2019 published vide No ERTS(T) 4/2019/Pt/35 dated 13.12.2019, all functions provided under the Meghalaya Goods and Services Tax Rules,2017.

This notification shall be deemed to have come into effect from 22<sup>nd</sup> June, 2017.
