Read: Circular No. 5/15/2016-IND/465 dated 04-12-2018.

The Government of India has enacted the Micro Small and Medium Enterprises Development Act, 2006, published in the Gazette of India dated 16-06-2006 (Act No. 27 of 2006) w.e.f. 2nd October, 2006. Based on this, the Government of Goa has framed the Rules for "Goa Micro, Small and Medium Enterprises Development Rules, 2007" under section 30, read with sub section (3) of Section 21 of the Micro Small Medium Enterprises Development Act, 2006 (MSMED Act, 2006).

Accordingly, the State Government has appointed the Director of Industries, Trade and Commerce as the Chairperson along with 4 other members i.e. Representative of GSIA, Representative of LDM Lead Bank (SBI), Advocate and Chartered Accountant for the Goa Micro and Small Enterprises Facilitation Council (GMSEFC) under the provisions of the MSMED Act, 2006.

The pending cases under delayed payment, are being monitored by the office of the Secretary, MSME, New Delhi. The Hon'ble Minister of Micro, Small & Medium Enterprises (MSMEs) has noticed the Samadhan Portal and found that a number of applications/cases for delayed payments are currently under consideration and some are yet to be viewed. It is due to Covid-19 and Ukraine war, the Indian MSMEs are struggling with peculiar finance crunch and in such a situation all the organizations/Departments/PSUs should ensure to

make timely payments for Micro and Small Enterprises (MSEs) and settle their claims.

In view of the above, all the organizations/Departments/PSUs are hereby strictly directed to ensure timely payments for MSMEs and settle their claims on priority. Furthermore, the State Public Sector Undertakings are also advised to join and transact on the TReDS (Trade Receivables Discounting System) a platform, which is set up to facilitate discounting of invoices for MSMEs for corporate buyers through multiple financiers.
