ORDER:

The Insurance Commissioner, ESI Corporation, New Delhi in the letter first read above has gives a notice with intention to extend the provisions of the Employees' State Insurance Act, 1948 (Act No. 34 of 1948), to the Municipal Corporation and Municipal Councils/Bodies.

- After careful examination of the notice of the Insurance Commissioner, ESI Corporation, New Delhi, the Government of Andhra Pradesh have decided to extend the Employees' State Insurance Act, 1948 for coverage to Casual / Contractual Agencies working under Municipal Corporation Municipal Councils in the state of Andhra Pradesh.
- 3. Accordingly, a preliminary notification has been published in the Andhra Pradesh Gazette No.1905, dated 28.11.2022 as per the G.O.4th read above calling objections under sub-section (5) of section 1 of the Employees State Insurance Corporation Act, 1948.
- The Director, IMS in his letter 5th read above has informed that there are no objections received to Director, Insurance Medical Services, AP, regarding the said notification.

Final Notification

In exercise of the powers conferred by sub-section (5) of Section 1 of the Employees' State Insurance Act, 1948, the Government of Andhra Pradesh, Department of Labour, Factories, Boilers and Insurance Medical Services (IMS&VIG) (P.T.0) in consultation with the Employees' State Insurance Corporation and with the approval of the Central Government vide Letter No. S-38025/07/2020-SS-1 dated: 09.06.2021, hereby extend the provisions of the Act, to the classes of establishments specified in the schedule, as the same having been previously published in Part-I Extra Ordinary issue of the Andhra Pradesh Gazette No.1905, dated: 28th November, 2022 vide G.O.
